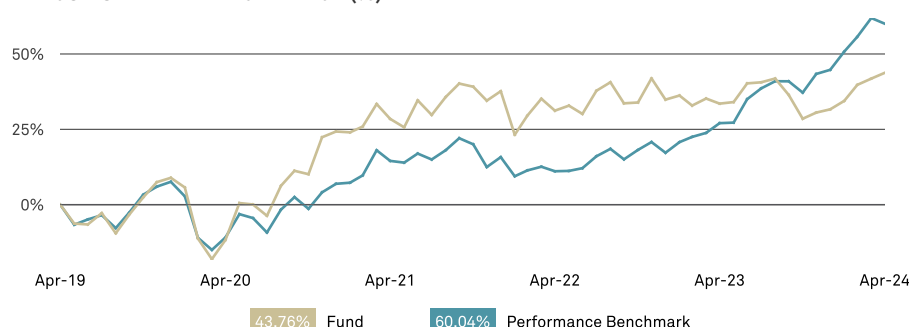
PERFORMANCE BENCHMARK

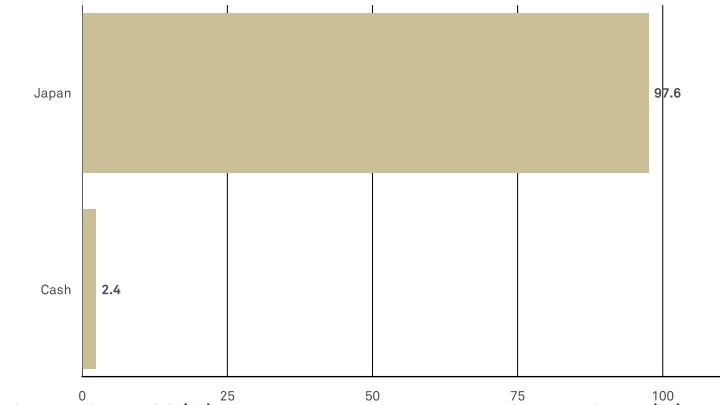

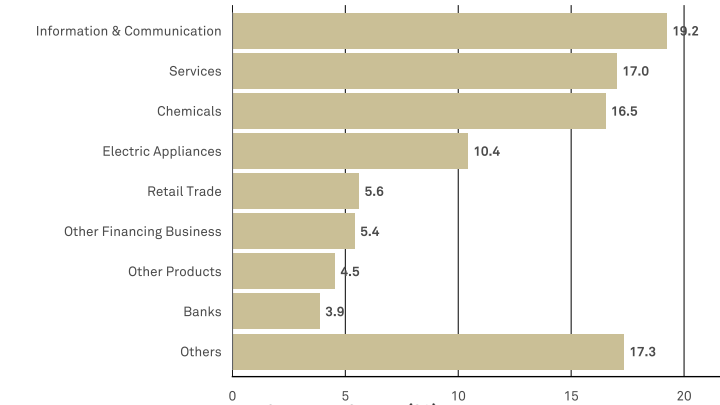

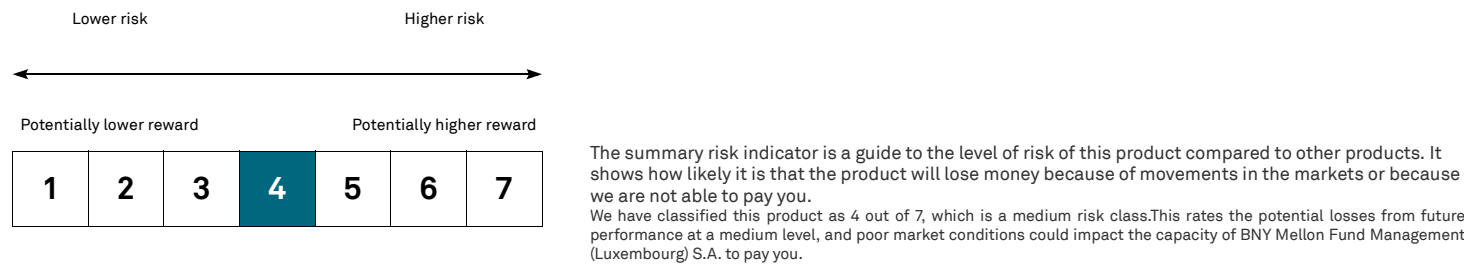
