






The fund predominately invests in USD denominated bonds and any non-USD based investment is fully hedged back into USD. The fund aims to deliver a return over the entire economic cycle that is higher than what could be achieved with bonds issued by borrowers in industrialized nations. The large investment universe offers interesting investment opportunities and allows for a broad diversification. The fund is actively managed in terms of its investment approach.



In % of total economic exposure





#### Performance review

On the performance side, the fund produced a negative return that was also below its benchmark. The main driver for the relative underperformance was our duration and yield-curve positioning, given our longer duration bias and rising US Treasury rates. Neither our sector allocation nor our security selection had a meaningful impact on the relative performance during April.

#### Market Review

In April, the performance of emerging market investment-grade corporate bonds was negative as tighter credit spreads were not able to offset the negative impact from rising US Treasury yields. In the US, 2-year Treasury yields rose by 41 basis points (bps) while yields on 10-year and 30-year Treasury bonds increased by 48 bps and 44 bps, respectively. The US Treasury curve remains inverted with the yield differential between 2- and 10-year US Treasury notes ending the month at -36 bps. A main driver for the month was US inflation data, which provided further evidence that US inflation is stickier than previously anticipated. This led to a re-pricing of expected interest rate cuts and a meaningful upward move in yields across the US Treasury curve. On the credit side, EM investment-grade credit spreads tightened by 14 bps with similar changes across A-rated and BBB-rated issuers. Of the three main emerging market investment-grade regions, credit spreads of Latin American issuers slightly outperformed Middle Eastern and Asian issuers.
