



The fund is built on an entirely bottom-up driven investment process and a disciplined focus on intrinsic value, which are crucial to delivering sustainable long-term returns. Currency risks are fully hedged into the respective share class currency.



# Risk profile<sup>2</sup>



In % of total economic exposure





#### Performance review

The fund held up well against the rather weak convertible bonds market and was able to further extend its outperformance compared to the benchmark in April. In a month in which all sectors except Utilities posted modest negative returns, the fund's security selection was the main return driver with selections in Communication Services, IT, and Materials contributing the most. While markets are normalizing from several shocks (pandemic, supply chain disruptions, rising inflation, and wars) and interventions by governments and central banks, higher interest rates and increased volatility do not seem to be leveling off. The fund's high-conviction approach and focus on the fundamental value of an investment continued to help navigate through this volatile market environment. The largest absolute contributors for the month were positions in the convertible bonds (CBs) of Ivanhoe Mines (24 bps), Bharti Airtel (18 bps), and Transmedics Group (18 bps), which gained 17%, 8%, and 14%. The global copper shortage is putting the miner Ivanhoe Mines into the spotlight, whose shares are up more than 40% (in CAD) year-to-date and whose CB was one of the best-performing securities in the CB universe in April. Bharti Airtel continued to perform well by gaining market share (new subscriber additions), while Transmedics Group – a leading organ transplant company – significantly increased its 2024 guidance. The worst absolute contributors were positions in the CBs of Wayfair (-34 bps), Microsoft (-16 bsp), and Exact Sciences (-14 bps): the respective CBs fell by 17%, 6%, and 10%. While a weaker economic environment continues to weigh on home spending and on Wayfair's prospects, Microsoft fell in line with the broader stock market, giving up some of the previous months' gains. Exact Sciences' investment case was confirmed by a competitor's data readout, while its share price fell. Two investments were sold during the month without adding any new positions. As of the end of the month, the fund had an ESG (environmental, social, gover

# Market Review

April managed to derail the strong rally in risky assets from the previous five months, at least temporarily. Global convertible bonds, as measured by Refinitiv, lost 2.4% in April. Global equities (USD-hedged) retreated by 3.17%, reversing most of the gains they made in March but remaining comfortably in positive territory YTD (+4.84%). The yield on 10-year Treasuries saw a double-digit increase and ended the month at 4.68%, its second highest monthly close since 2007. It was the relentless march higher in yields coupled with the admission that the potential rate cuts by the US Federal Reserve might not be as numerous and as early in the year as previously anticipated, that was seen by market participants as the main factor behind the shift in sentiment. The implied number of Fed hikes/cuts through the end of January 2025 (as priced by the bond futures markets) declined to less than 1.5 cuts at the end of April from 3.5 cuts at the end of April from 3.5 cuts at the end of April from 3.5 cuts at the end of the first quarter (and seven rate cuts at the end of 2023). Investment-grade credit spreads were little changed, continuing to hover within a 10-basis point ("bps") range from their all-time low in late 2019. High-yield spreads saw a modest widening but, once again, the better carry provided a much-needed cushion, resulting in a monthly loss of just 0.68% for high-yield bonds and making them the best performing fixed-income strategy in April. Having strengthened throughout the first quarter, the US dollar continued to rally against the basket of currencies comprising the U.S. Dollar Index (DXY) in the early second quarter, gaining 1.66% over the course of the month. Despite the strong dollar headwinds, gold surged for the first half of the month but then retreated from the psychological level of USD 2,400/oz to end April just 2.9% higher.
