# BlueBay Investment Grade Euro Government Bond Fund

# **Investment objective**

The fund is actively managed and targets better returns than its benchmark, the Bloomberg Euro Aggregate Treasury Index, while taking into account Environmental, Social and Governance ("ESG") considerations.

### Investment strategy

- There are no restrictions on the extent to which the fund's portfolio and performance may deviate from the ones of the benchmark.
- At least two-thirds the fund's investments will be in fixed income bonds rated investment grade issued based in European Union countries and the UK. At least twothirds of the fund's investments will be denominated in currencies of European countries.
- Up to one-third of the fund may be denominated in currencies of non-European countries and the UK whose sovereign debt rating is investment grade.
- Up to 15% of the fund's assets may be invested in fixed income bonds rated below investment grade, provided that such bonds are not rated below B-/B3.
- The Fund meets the conditions set out in Article 8 of the Sustainable Finance Disclosure Regulation as it promotes environmental/social characteristics through binding requirements as a key feature. 

### Outlook

- Inflation is still sticky. Core US inflation is at 3.8%, while in Europe, it declined to 2.7% from 2.9%.
- Economic activity remains healthy in the US and has also picked up in Europe, supported by labour markets.
- We believe rate expectations are now largely appropriate on both sides of the Atlantic.
- · We think inflation data is more important for the direction of policy and markets than activity data for now.
- The Federal Reserve is keen to cut rates but needs better inflation data to justify it, while the European Central Bank is guiding for a June cut.
- The markets could rally into summer if we see better inflation data in the US and the economy continues to grow. Any upside surprise to inflation is more likely to be a catalyst for a bigger reversal in risk assets.
- We still like shorts in Japanese and UK long-term bonds and curve-steepening trades in the US. We prefer emerging-market hard-currency sovereigns to European.






# Important risk considerations

# BlueBay: Issuer fundamental ESG risk ratings<sup>3</sup>



#### **Notes**

- 1. While gross of fees figures would reflect the reinvestment of all dividends and earnings, it would not reflect the deduction of investment management and performance fees. Scores range from '+3" through to '-3' and indicates the extent to which ESG is considered investment materials, as well as the nature and scale of the materiality impact (i.e. positive credit impact, negative credit impact, no credit impact).
