Investment Objective and Philosophy

The Cohen & Steers SICAV European Real Estate Securities Fund (the "Fund") seeks current income and capital appreciation by investing in REITs and other publicly traded real estate companies located in Europe. The Fund seeks to identify companies that we believe have superior growth prospects and attractive valuations. We believe the European markets offer the potential for superior returns based on variations in country-specific economic and property sector cycles and the diversity of business models. Within the European real estate securities markets, we believe there will be alpha generation opportunities for well-resourced, disciplined, active managers.

Investment Approach

Cohen & Steers employs an integrated, relative value investment process. A proprietary valuation model ranks European real estate securities on price/net asset value ("NAV") and price/dividend discount model value ("DDM"), which we believe are the primary factors of real estate security valuation. Analysts incorporate both quantitative and qualitative analysis in their estimates. The company research process includes an evaluation of management, strategy, property quality, financial strength and corporate structure. Judgments with respect to risk management, diversification, liquidity and other factors overlay the model's output and drive the portfolio managers' investment decisions.

short-term and long-term debt and then dividing by the company's total assets.
