



## INVESTMENT STRATEGY

Candriam Sustainable Money Market Euro, a sub-fund of the Candriam Sustainable sicav, invests in money market instruments, cash and financial instruments and bonds with a residual maturity of under 24 months and a minimum rating of A2/P2 or equivalent by one of the 3 ratings agencies. Issues are denominated in EUR or currencies from OECD countries. The fund may use foreign exchange, interest rate and/or credit derivatives for hedging. The fund invests exclusively in companies and countries with the strongest sustainable development positioning. All issuers are compliant with the principles of the UN Global Compact (companies) and with major treaties and conventions (countries). The fund's sustainable investment objective is to reduce greenhouse gas emissions whilst also seeking to achieve a long term positive impact on social and environmental dimensions. The fund is managed actively, with reference to the index mentioned on page 2. 
## INVESTMENT HORIZON: 3 MONTHS





## RATING ALLOCATION\* (%)




## MATURITY BREAKDOWN (%)
