

### **Investment Strategy**

The investment objective of the Fund is long-term capital growth that outperforms the benchmark MSCI Europe Micro Cap Index over a medium to long-term period. The main driver for this is the above-average earnings growth of the selected companies. The strategy is based on a disciplined bottom-up stock selection of attractive smaller companies (market capitalisation up to 1bn EUR) based in Europe. Investments are made in established niche companies that achieve sustainable and above-average growth over long periods with high profitability. The decisive criteria are in particular end markets with structural growth, high entry barriers and excellent management teams.

- Diversified portfolio of 90-120 stocks
- Use of information inefficiencies in the case of titles that receive little attention
- Long-term investment horizon and low portfolio turnover
- Active approach, i.e. index weights have no influence on individual stock selection

# Fund management comment

 $The \ S\&P \ 500 \ Index \ lost \ more \ than \ 4\% \ in \ April \ and \ recorded \ its \ first \ negative \ month \ after \ five \ positive \ months \ in \ a \ row.$ This burdened the equity markets despite a good reporting season. In this environment, the micro-cap indices outperformed their large-cap counterparts. We benefited from a positive selection in IT, communications and energy. However, the negative selection in healthcare and industrial stocks and our underweight in the financial sector outweighed this. The Berenberg European Micro Cap therefore underperformed the benchmark in April. The Addvise and Mildef shares fell due to weaker-than-expected results for the first quarter. The 2G Energy share posted a solid performance in the first quarter 2024 following the publication of a strong order intake. Medcap shares also made a positive contribution without any particular news flow. We further increased our position in Momentum Group in April due to the company's strong fundamentals. Following the takeover bid from San Donato, we sold our position in Medica at an extremely attractive pri-


# Currency allocation
