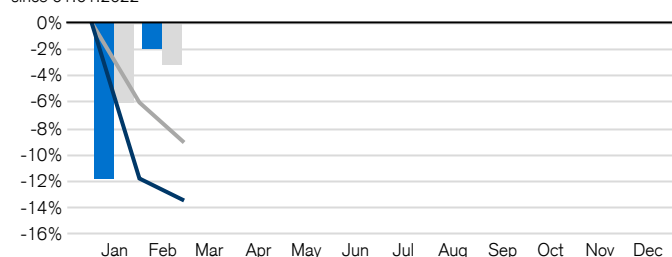

## Investment Policy

The fund assets are invested worldwide following a thematic approach across all our high-conviction themes. We currently invest in six high growth themes: security, robotics, digital health, edutainment, environmental impact, and infrastructure. These thematic equity strategies are supported by a number of long-term structural growth drivers, such as increasing digitalization and connectivity, globalization and demographic trends, the need for productivity and efficiency, as well as the emergence of millennials' values. Within these themes, we invest in companies with a "pure-play" focus, which we define as having at least 50% revenue exposure directly attributable to their investment theme.

## Performance overview\* - monthly & cumulated

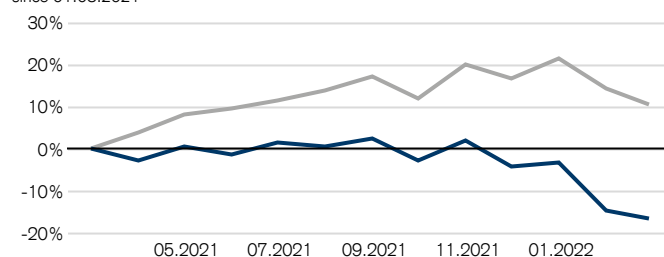

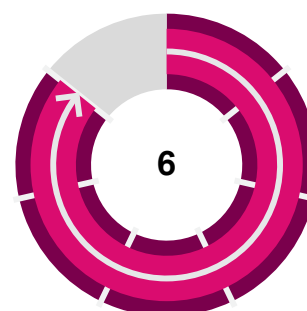
