

## KEY INVESTOR INFORMATION

UBAM is a SICAV managed by UBP Asset Management (Europe) S.A.

### Objectives and investment policy

The Fund seeks to grow capital and generate income primarily by investing in regulated UCITS and non-UCITS funds which have as investment objective to invest in alternative strategies such as but not limited to Equity Long Short, Equity Market Neutral, Fixed Income, Global Macro, Commodity Trading Advisor (trend followers). The non UCITS funds will be submitted to a regulatory supervision equivalent to a UCITS.

The Fund will not invest in funds which invest mainly in Contingent Convertible bonds ("CoCos") but could invest in CoCos, through funds which invest on an ancillary basis in CoCos.

The Fund is actively managed investing mainly in securities denominated in US Dollars, but some foreign currency exposure may be taken. These investments may or may not be hedged at the Investment Manager discretion.

The Fund is not managed in reference to a benchmark.

Investments are chosen from a carefully selected range of funds. The selection consists of a quantitative and qualitative screening including on-site visits and interviews of the fund manager, and a performance of due diligence analysis (review of the investment strategy, risk management, back office functions and support systems).

The Fund may from time to time hedge part of the market risk of the underlying UCI or UCITS. Furthermore, derivative instruments may be used for the purposes of efficient portfolio management. On an ancillary basis, the Fund may also invest in liquid assets to manage his cash position.

The Fund's value is calculated and expressed in US Dollars.

The currency risk in relation to the base currency USD is mainly hedged.

Investors in the Fund can redeem their units on a weekly basis, each Friday, although we recommend a holding period of minimum five years.

As a fund of funds implementing alternative strategies, investors should be aware that the value of their holdings could fall and that they may not get back their initial investment.

Any income received by the Fund is reinvested (capitalisation share class).

### Risk and reward profile



This indicator represents the annual historical volatility of the Fund over a 5-year period.

Risk Category 3 reflects limited potential gain and/or loss in the value of the portfolio.

This is due to investments in alternative UCITS funds.

Significant risk(s) for the Fund not taken into account in this indicator include the following:

**Counterparty risk:** As the Fund uses over-the-counter derivatives, there is a risk that the counterparty to the transactions will wholly or partially fail to honour its contractual obligations. This may result in a financial loss to the Fund.

**Currency risk:** The Fund invests in overseas markets. It can be affected by changes in exchange rates which may cause the value of your investment to decrease or increase.

**Liquidity risk:** Liquidity risk exists when particular investments are difficult to purchase or sell. This can reduce the Fund's returns because the Fund may be unable to transact at advantageous times or prices.

## Charges

The charges and commissions are used to cover the Fund's operating costs, including marketing and distribution of shares. These charges reduce the potential growth of your investment.


