### Objectives and investment policy

El Fondo se gestiona de manera activa y sin referencia a ningún índice.

El Fondo tiene como objetivo principal proporcionar ingresos regulares en forma de dividendos y, en segundo lugar, generar un crecimiento del capital invirtiendo en diferentes clases de activos en países emergentes, que incluyen valores de renta variable, deuda estructurada, bonos de empresas, bonos de alto rendimiento, bonos gubernamentales, bonos convertibles e instrumentos de efectivo.

Puede invertirse en acciones de China continental limitadas a inversores extranjeros, como acciones de clase A de China, que pueden cotizar en un Stock Connect o mediante el uso de una licencia específica concedida por las autoridades chinas, y puede invertir en títulos de deuda negociados en el mercado de bonos interbancarios de China.

El equipo de inversiones aplica asimismo la Política de inversión sostenible de BNP PARIBAS ASSET MANAGEMENT, que tiene en cuenta los criterios ambientales, sociales y de gobernanza (ESG, por sus siglas en inglés) en las inversiones del Fondo.

Los ingresos se reinvierten sistemáticamente.

Los inversores podrán efectuar reembolsos diariamente (los días hábiles bancarios en Luxemburgo), como se describe en el folleto.

Esta clase de acciones tiene como objetivo cubrir la rentabilidad de la cartera de USD a EUR.

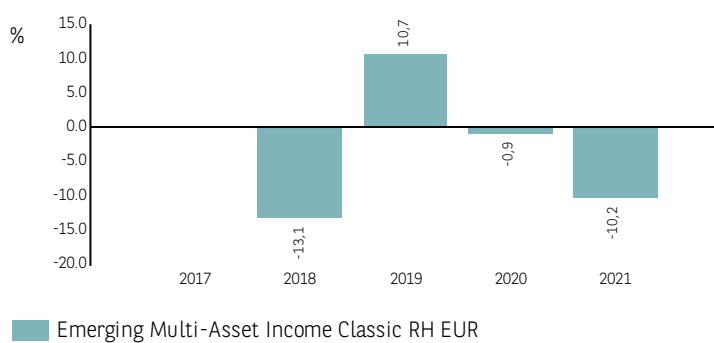
