Objective and investment policy

The Fund aims to provide a combination of capital growth and income to deliver a return that is higher than that of the short-dated investment grade corporate bond market over any five-year period, while applying the ESG Criteria.

Core investment: at least 80% of the Fund is invested, directly or via derivatives, in high quality bonds issued by companies from anywhere in the world. These securities can be denominated in any currency. The Fund typically invests in bonds which have short repayment dates and, as a result, it has a low portfolio duration. The Fund aims to hedge any non-euro assets back to euro. The Fund invests in securities that meet the ESG Criteria, applying an Exclusionary Approach as described in the precontractual annex.

Other investments: the Fund may invest in bonds issued by companies with a longer time to repayment and uses derivatives to reduce their sensitivity to interest rate movements. The Fund may also invest in lower quality bonds, government bonds and cash or assets that can be turned into cash quickly.

Derivatives: for investment purposes and to reduce risk and cost.

Strategy in brief:

- Investment approach:

the bonds held in the Fund are generally issues due to be repaid within a short period to minimise the effect of interest rate movements on the Fund's value. Asset allocation and bond selection are at the heart of the Fund's investment process. The investment manager has the flexibility to spread the portfolio across issuers, sectors and countries, supported by in-depth research by an in-house team of analysts.

- Investment manager's ESG classification: Planet+ / ESG Enhanced, as defined in the Fund's Prospectus.

Benchmark: Markit iBoxx EUR Corporates 1-3 year Index

The benchmark is a comparator against which the Fund's performance can be measured. The index has been chosen as the Fund's benchmark as it best reflects the scope of the Fund's investment policy. The benchmark is used solely to measure the Fund's performance and does not constrain the Fund's portfolio construction. The Fund is actively managed. The investment manager has complete freedom in choosing which investments to buy, hold and sell in the Fund. The Fund's holdings may deviate significantly from the benchmark's constituents. For unhedged and currency hedged share classes, the benchmark is shown in the share class currency.

Other information

You can buy and sell shares in the fund on any business day. Instructions received before 13:00 Luxembourg time will be dealt at that day's price.

Any income from the fund may be paid out to you quarterly.

In addition to the charges set out in the charges section, the fund will incur portfolio transaction costs which are paid from the assets of the fund. These may have a material impact on your returns.

Recommendation: This fund may not be appropriate for investors who plan to withdraw their money within 5 years.

The main risks that could affect performance are set out below:

■ The value and income from the fund's assets will go down as well as up. This will cause the value of your investment to fall as well as rise. There is no guarantee that the fund will achieve its objective and you may get back less than you originally invested.

■ Investments in bonds are affected by interest rates, inflation and credit ratings. It is possible that bond issuers will not pay interest or return the capital. All of these events can reduce the value of bonds held by the fund.

■ High yield bonds usually carry greater risk that the bond issuers may not be able to pay interest or return the capital.

■ The fund may use derivatives to profit from an expected rise or fall in the value of an asset. Should the asset's value vary in an unexpected way, the fund will incur a loss. The fund's use of derivatives may be extensive and exceed the value of its assets (leverage). This has the effect of magnifying the size of losses and gains, resulting in greater fluctuations in the value of the fund.

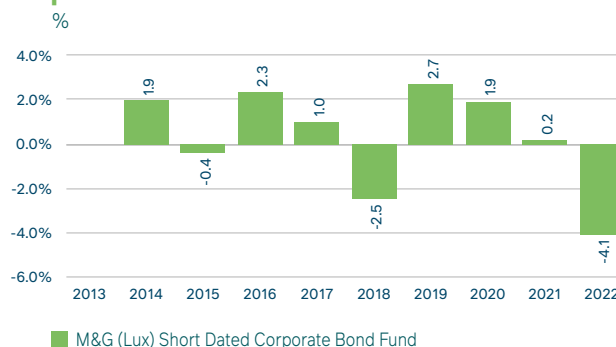
The entry and exit charges shown are the maximum figures and, in some cases, you may pay less. The ongoing charge is based on expenses for the period/year ending 30 September 2022. This figure may change from year to year. It excludes portfolio transaction costs. This figure includes extraordinary expenses and underlying charges for closed-ended-funds, such as investment trusts and Real Estate investment trusts.

For Distribution shares, the ongoing charge is taken from investments held in the fund's portfolio and not from the income these investments produce. The deduction of this charge will reduce the potential growth of your investment.
