This Fund is managed by BNP PARIBAS ASSET MANAGEMENT Luxembourg, part of the BNP Paribas Group.

Objectives and investment policy

This Fund is actively managed. The composite benchmark 20% Bloomberg Euro Aggregate 1-3 years + 80% €STR is used for performance comparison only. The Fund is not benchmark constrained and its performance may deviate significantly from that of the composite benchmark.

The Fund seeks to achieve a return that is higher than Euro Money Market over a recommended investment horizon of around 36 months by using an actively managed flexible bond strategy while maintaining a high level of liquidity.

It is managed based on a flexible approach combining active and fundamental approaches on duration management, yield curve position, country allocation, issuer selection as well as on OECD Currencies. This process is combined with internal sustainability extra financial research capabilities as well as macro and credit research and quantitative analysis forces.

The selection process comprises four phases, each run by ad hoc committees: the identification of macro economic trends, an assessment of the major fixed income asset classes, an allocation by sector, country and maturity as well as risk budget based and finally a portfolio construction based on the aforementioned phases.

The exposure level to Investment Grade Fixed Income and Money Market instruments will be comprised between 50% and 100%.

The exposure to Non Investment Grade Fixed Income instruments such as High Yield debt instruments may reach up to 30% and the cumulated exposure to High Yield and non-rated debt instruments may reach up to 40%.

After hedging, exposure to currencies other than the EUR will be less than 40%.

The sub-fund may not be invested or exposed to equities.

Environmental, social and governance (ESG) criteria contribute to, but are not a determining factor in, the manager's decision making.

Incomes are systematically reinvested.

Investors are able to redeem on a daily basis (on Luxembourg bank business days) as described in the prospectus.

- Why is the Fund in this specific category?
The risk category is justified by the investment mainly in Interest Rate instruments. The investor's attention is drawn to the fact that an increase in interest rates results in a decrease in the value of investments in bonds and debt instruments and more generally fixed income instruments.
- The higher the risk, the longer the recommended investment horizon.

Other risks materially relevant to the Fund which are not adequately captured by the indicator are described below:

- **Credit Risk:** This risk relates to the ability of an issuer to honour its commitments: downgrades of an issue or issuer rating may lead to a drop in the value of associated bonds.
- **Counterparty Risk:** This risk is associated with the ability of a counterparty in an Over The Counter financial transaction to fulfil its commitments like payment, delivery and reimbursement.
- **Operational and Custody Risk:** Some markets are less regulated than most of the international markets; hence, the services related to custody and liquidation for the subfund on such markets could be more risky.
- **Derivatives Risk:** When investing in over the counter or listed derivatives, the Fund aims to hedge and/or to leverage the yield of its position. The attention of the investor is drawn to the fact that leverage increases the volatility of the subfund.

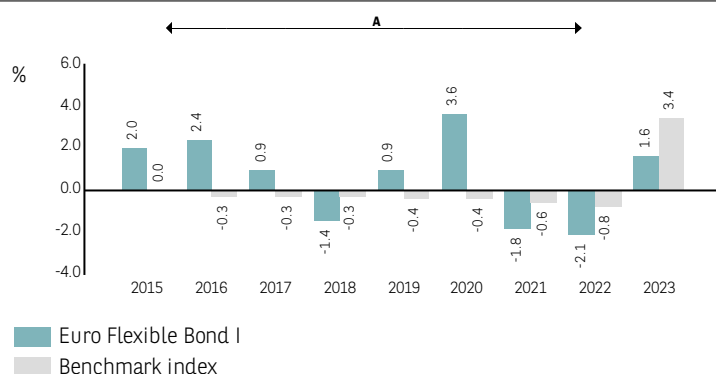
