Objectives and Investment Policy

The aim is to increase the value of your investment and to earn income within the Fund over the long term by investing mainly in UK companies.

The Fund invests in shares and convertible securities (tradable debt which can be converted into shares) issued by companies, across a range of industries, based in the UK and traded on stock exchanges in the UK or in other developed countries. The Fund selects companies which it feels offers strong opportunities for growth and focuses on investing in small to medium sized UK companies.

The Fund is actively managed which means the investment manager has discretion to select the companies it chooses to invest in. However, the investment manager does take into consideration the universe of companies represented by the FTSE


