**Aviva Investors - Emerging Markets Local Currency Bond Fund, Class I, Accumulation shares, EUR**, a sub-fund of Aviva Investors (ISIN: LU0273498039). The Fund is managed by Aviva Investors Luxembourg S.A.

## OBJECTIVES AND INVESTMENT POLICY

The objective of the Fund is to earn income and increase the value of the Shareholder's investment over time.

The Fund invests mainly in the currencies of emerging market countries and in bonds issued by corporations and governments in these countries. At all times, the Fund invests at least two-thirds of its total net assets (excluding cash & cash equivalents) in bonds that are rated at least B- by Standard and Poor's and Fitch or B3 by Moody's. The Fund will also use derivatives for investment purposes.

The Investment Manager actively makes the investment selection decisions for the Fund.

You can buy and sell shares on any full bank business day in Luxembourg.

Recommendation: this Fund is designed for investors who plan to invest for at least 5 years.

This is an accumulation share class and any income from the Fund will remain in the Fund and is reflected in the share price.

**China country risk:** changes in China's political, legal, economic or tax policies could cause losses or higher costs for the Sub-Fund.

**Credit risk:** A bond or money market security could lose value if the issuer's financial health weakens.

Below investment grade bonds (also known as high yield securities) typically have greater credit risk than investment grade securities.

**Currency risk:** Changes in currency exchange rates could reduce investment gains or increase investment losses. Exchange rates can change rapidly, significantly and unpredictably.

**Default risk:** Issuers of certain bonds or money market instruments could become unable to make payments on their bonds, causing a reduction in income to the Fund and also in the value of bonds held by the Fund. Under extreme market or economic conditions, defaults could be widespread and their effect on Fund performance significant.

**Derivatives risk:** Derivatives are instruments that can be complex and highly volatile, have some degree of unpredictability (especially in unusual market conditions), and can create losses significantly greater than the cost of the derivative itself.

**Emerging markets risk:** Compared to developed markets, emerging markets can have greater political instability and limited investor rights and freedoms, and their securities can carry higher equity, market, liquidity, credit and currency risk.

**Illiquid securities risk:** Certain assets held in the Fund could, by nature, be hard to value or to sell at a desired time or at a price considered to be fair

(especially in large quantities), and as a result their prices could be very volatile.

**Leverage risk:** A small price decline on a "leveraged" underlying investment will create a correspondingly larger loss for the Fund. A high overall level of leverage and/or unusual market conditions could create significant losses for the Fund.

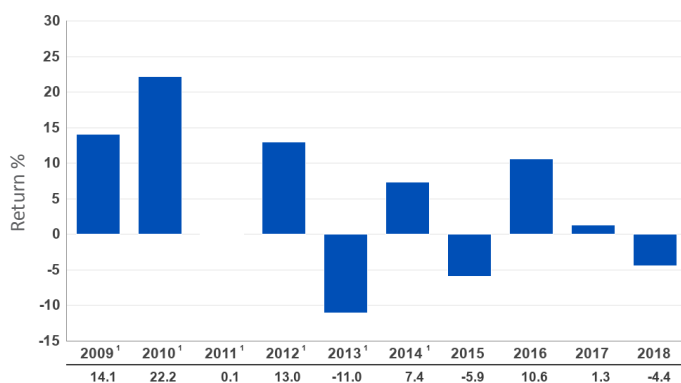
The charges you pay are used to pay the costs of running the Fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.
