





On 01.05.2021 the Tokyo Stock Exchange 1st Section index (TOPIX) (Net TR) replaced the Tokyo Stock Exchange 1st Section Index (TOPIX) (TR). The Schroder ISF Japanese Large Cap fund was launched in December 2006 to accommodate a transfer of shareholders from the Schroders Japan Fund Unit Trust (launched on May 1994) to the Schroder ISF SICAV. On 29.03.2012 the Tokyo Stock Exchange 1st Section Index (TOPIX) (TR) replaced the FTSE Japan. The full track record of the previous index has been kept and chainlinked to the new one. On 02.04.2012 Schroder ISF Japanese Large Cap changed its name to Schroder ISF Japanese Opportunities.
