## Investment Objective

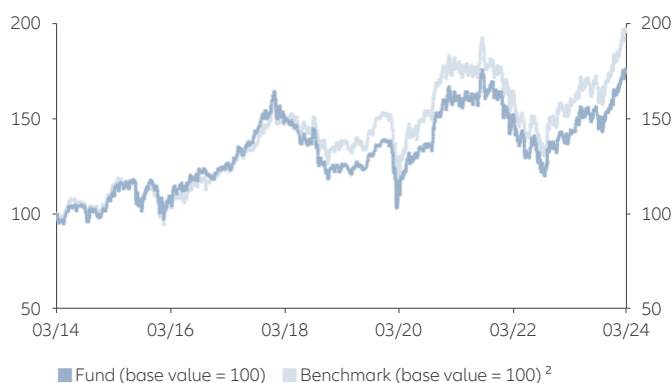

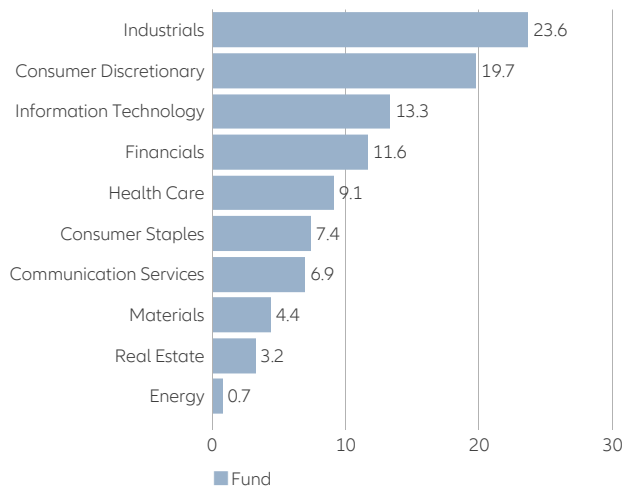
