Objectives and investment policy

The fund is passively managed. The aim is for your investment to reflect the performance of the MSCI Europe Consumer Staples ESG Screened 20-35 Select Index (index). The index is based on the MSCI Europe Consumer Staples Index (Parent Index), which is designed to reflect the performance of shares in large and medium capitalisation companies across certain developed markets in Europe which are classified in the consumer staples sector as per the Global Industry Classification Standard®. In order to be eligible for inclusion in the index, companies must be eligible for inclusion in the Parent Index and must meet certain ESG screening criteria. Securities which breach the following ESG standards, amongst others, are excluded: (i) are associated with controversial, civilian, conventional and nuclear weapons and tobacco, (ii) are assigned an MSCI ESG Rating of CCC, (iii) derive revenues from thermal coal and oil sands extraction, and (iv) are not in compliance with the United Nations Global Compact principles. The weight of the largest group entity in the index is capped at 31.5% and the weights of all other entities are capped at 18% at each quarterly index rebalancing. Where the largest group entity has exceeded 35% or any other entity has exceeded 20% in the lead up to each monthend, such entities will be rebalanced to 31.5% and 18% respectively. 
Charges

To the extent the fund undertakes securities lending to generate revenue, the fund will ultimately be allocated 70% of the associated revenue, the securities lending agent, which will be a DWS entity or other Deutsche Bank entity, will be allocated 15% and the remaining 15% will be allocated to the DWS entity which monitors such activities, as set out in the prospectus. As securities lending revenue sharing does not increase the costs of running the fund, this has been excluded from the composition of costs.
