Objectives and investment policy

The Fund's objective is to achieve long term capital growth. The Fund will invest in the shares of financial sector companies on an international basis. The Fund will also invest, to a lesser extent, in the shares of property related companies.

The Fund has the power to use derivative instruments for investment purposes. Derivatives allow the Investment Manager to track changes in the price of an item, for example a company share, without actually owning it. Derivatives may be used to gain exposure to a number of different asset classes, including company shares, financial indices, commodities and currency exchange rates. The Fund may also use derivatives for hedging purposes. Investment in financial derivative instruments can introduce significant leverage risks and lead to high volatility.

Any income arising in relation to this share class will be accumulated (i.e. automatically reinvested and reflected in the price of the shares).

The Investment Manager is free to invest in any type of investment he chooses, without reference to a particular benchmark. The Investment Manager is likely to change the investments in the Fund on a regular basis. Costs are incurred each time the Fund buys or sells investments. Costs will affect Fund performance.

Investors are able to buy and sell shares during any business day. If you tell us to buy or sell shares before 1pm (Luxembourg time) on any business day we will make the transaction on the same day. If you tell us to buy or sell shares after 1pm (Luxembourg time) we will make the transaction on the following business day.

Risk and reward profile

The Risk and Reward Indicator table demonstrates where the Fund ranks in terms of its potential risk and reward. The higher the rank the greater the potential reward but the greater the risk of losing money. It is based on past data, may change over time and may not be a reliable indication of the future risk profile of the Fund. - The lowest category does not mean 'no risk'.


