#### Objectives and investment policy

This Fund is actively managed. The composite benchmark 80% €STR index+ 20% Bloomberg Euro Aggregate 1-3 Years (EUR) index is used for 1) the investment objective, and 2) performance comparison. The Fund is not benchmark constrained and its performance may deviate significantly from that of the composite benchmark.

The Fund is not a Money Market Fund as defined by the Money Market Regulation 2017/1131. The Fund seeks to achieve a performance that is higher than the composite benchmark 80% €STR index + 20% Bloomberg Euro Aggregate 1-3 Years (EUR) index over a minimum investment period of six months, by using an enhanced bond strategy aims at combining a very low sensitivity with a high level of liquidity, with the objective of delivering returns higher than ultra short-term bonds yields (lower than 2 years) through the use of Fixed income and Money Market instruments, and derivatives related to these instruments.


Exposure to currencies other than the EUR will be less than 5%.

Investment grade structured debts may represent up to 20% of the assets. It may not be invested in equities.

Environmental, social and governance (ESG) criteria contribute to, but are not a determining factor in, the manager's decision making. Incomes are systematically reinvested.

Investors are able to redeem on a daily basis (on Luxembourg bank business days) as described in the prospectus

### Risk and reward profile

- Why is the Fund in this specific category?
   This risk category is justified by the investment in eligible money market instruments as per Regulation and short term bonds that have a low volatility.

Other risks materially relevant to the Fund which are not adequately captured by the indicator are described below:

- <u>Credit Risk:</u> This risk relates to the ability of an issuer to honour its commitments: downgrades of an issue or issuer rating may lead to a drop in the value of associated bonds.
- <u>Liquidity Risk</u>: This risk arises from the difficulty of selling an asset at a fair market price and at a desired time due to lack of buyers.
- Operational and Custody Risk: Some markets are less regulated than most of the international markets; hence, the services related to custody and liquidation for the subfund on such markets could be more risky.


