### **Fund description**






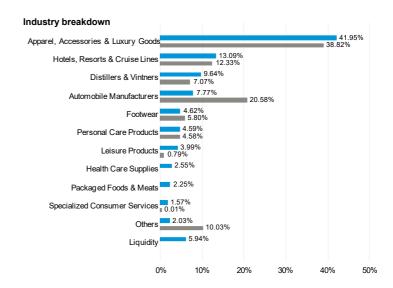
#### Asset allocation
