## Objective and Investment Policy

### Investment Objective

The Sub-Fund seeks to achieve long-term capital growth measured in USD by investing mainly in equities issued companies domiciled or operating predominantly in emerging markets.

### Investment Policy

The Sub-Fund is actively managed in order to capture opportunities in emerging market equities worldwide. Investment decisions are based on a combination of macroeconomic, sector and company specific analysis.

The share selection process relies on a rigorous analysis of the companies' business model, quality of management, growth prospects and overall risk return profile.

Emerging market countries cover countries generally considered low or middle income countries by the World Bank and countries included in any recognised emerging market index.

The Sub-Fund invests:

- at least two thirds of its total assets in equities and equities related instruments issued by companies domiciled or operating predominantly in the emerging market countries. The Sub-Fund may invest in equity securities of any market capitalisation (including small and micro-sized companies)
- up to 10% of its assets in convertible or straight bonds and not more than one third in money market instruments.

Within the limit of 200% of the Sub-Fund's net assets, the investment strategy may be achieved by direct investments and/or through derivatives. Derivatives may also be used for hedging purposes.

### Income

For Capitalisation share classes (Cap), the dividend is reinvested.

### Sub-Fund Currency

The reference currency of the Sub-Fund is USD.

### Investment Horizon

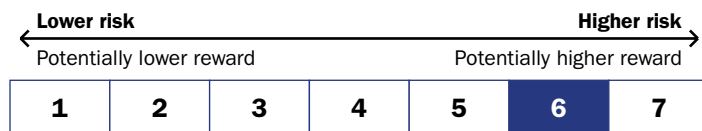
This Sub-Fund may not be suitable for investors who plan to withdraw their contribution within 8 years.

### Processing of subscription and redemption orders

The subscription, conversion or redemption orders must be received by the Registrar and Transfer Agent on any Valuation Day no later than 3 p.m. Luxembourg time. Orders will be processed at the Net Asset Value applicable to the following Valuation Day. The investor's attention is drawn to the existence of potential additional processing time due to the possible involvement of intermediaries such as Financial Advisers or distributors.

The Net Asset Value of this Sub-Fund is calculated on a daily basis.

## Risk and Reward Profile

### Why is this Sub-Fund in this category?

The capital of the Sub-Fund is not guaranteed. The Sub-Fund is invested in financial markets and uses techniques and instruments which may be subject to sudden and significant variation, which may result in substantial gains or losses.

### Additional Risks

**Counterparty Risk:** Risk of bankruptcy, insolvency, or payment or delivery failure of any of the Sub-Fund's counterparties, leading to a payment or delivery default.

**Geopolitical Risk:** investments in securities issued or listed in different countries may imply the application of different standards and regulations. Investments may be affected by movements of foreign exchange rates, changes in laws or restrictions applicable to such investments, changes in exchange control regulations or price volatility.

**Operational Risk:** Risk that operational processes, including those related to the safekeeping of assets may fail, resulting in losses.

**Liquidity Risk:** risk of low liquidity level in certain market conditions that might lead the Sub-Fund to face difficulties valuing, purchasing or selling all/part of its assets and resulting in potential impact on its net asset value.

**Credit Risk:** Risk that issuers of debt securities held in the Sub-Fund may default on their obligations or have their credit rating downgraded, resulting in a decrease in the Net Asset Value.

**Impact of any techniques such as derivatives:** Certain management strategies involve specific risks, such as liquidity risk, credit risk, counterparty risk, legal risk, valuation risk, operational risk and risks related to the underlying assets.

The use of such strategies may also involve leverage, which may increase the effect of market movements on the Sub-Fund and may result in significant risk of losses.

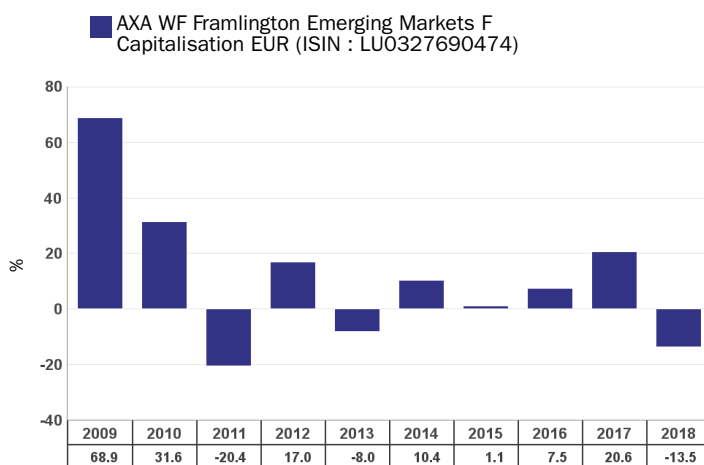
