Objectives and Investment Policy

Investment Objective:

The Fund aims to provide long term capital growth and income by investing in a portfolio of emerging markets bonds and other similar securities or instruments.

Investment Policy:

The Fund employs a Total Return strategy which has a flexible allocation across the emerging market debt universe. Through seeking multiple sources of return the strategy aims, over an investment cycle, to achieve risk-adjusted returns above those of the investment universe. However, your capital is still at risk and there is no guarantee of stable growth over time.

In normal market conditions, the Fund will mostly invest its assets in investment grade bonds (rated as such by a credit rating agency) and non-investment grade bonds (which carry more risk) issued by governments, government-related entities, supranational entities and companies that are based in or carry out the larger part of their business in emerging markets. As the markets the Fund invests in are considered to be emerging (meaning their economies are still developing), you could be exposed to some additional risk. The Fund may invest up to 10% of its assets in Chinese onshore bonds through the China Interbank Bond Market (CIBM). The Fund may also invest up to 49% of its assets in securities that can be quickly and easily turned into cash. The Fund will only do this if it

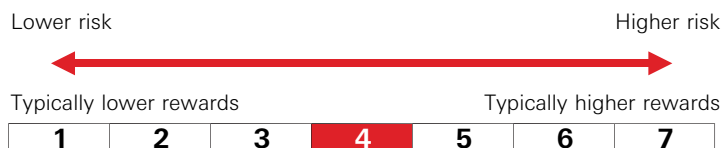
cannot find emerging market investments that meet the Fund's objective.

The Fund may also invest up to 25% of its assets in convertible bonds, up to 10% of its assets in contingent convertible securities, may invest in bank deposits, money market instruments for treasury purposes and up to 10% in other funds.

The Fund is managed to provide a US Dollar return. The Fund's primary currency exposure is to the US Dollar and emerging market currencies. The Fund may also use derivatives for hedging or efficient portfolio management purposes (such as to manage risks or costs or to generate additional capital or income). Derivatives may also be embedded in other instruments used by the Fund.

- ◆ The Fund may enter into securities lending transactions for up to 29% of its assets. However, this is not expected to exceed 25%.
- ◆ The reference currency of the Fund is USD. The reference currency of this share class is USD.
- ◆ The Fund is actively managed and does not track a benchmark. The reference benchmark for the Fund is Secured Overnight Financing Rate (SOFR).
- ◆ Income is distributed.
- ◆ You may sell your investment on most working days.
- ◆ Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within a period of 5 years.

Why is this Fund in this specific category?

Material risks not fully captured by the Risk and Reward Indicator:

- ◆ **Callable Bond Risk** Any unexpected behaviour in interest rates could negatively impact the performance of callable debt securities (securities whose issuers have the right to pay off the security's principal before the maturity date).
- ◆ **CoCo Bond Risk** Contingent convertible securities (CoCo bonds) are comparatively untested, their income payments may be cancelled or suspended, and they are more vulnerable to losses than equities and can be highly volatile.
- ◆ **Counterparty Risk** The possibility that the counterparty to a transaction may be unwilling or unable to meet its obligations.

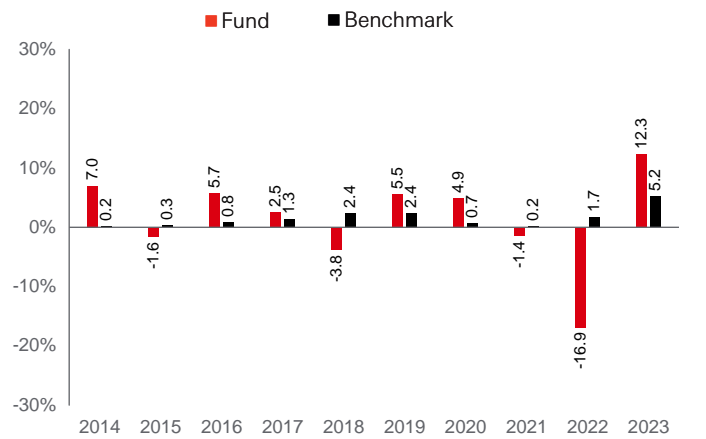
- ◆ **Credit Risk** A bond or money market security could lose value if the issuer's financial health deteriorates.
- ◆ **Default Risk** The issuers of certain bonds could become unwilling or unable to make payments on their bonds.
- ◆ **Derivatives Risk** Derivatives can behave unexpectedly. The pricing and volatility of many derivatives may diverge from strictly reflecting the pricing or volatility of their underlying reference(s), instrument or asset.
- ◆ **Emerging Markets Risk** Emerging markets are less established, and often more volatile, than developed markets and involve higher risks, particularly market, liquidity and currency risks.
- ◆ **Exchange Rate Risk** Changes in currency exchange rates could reduce or increase investment gains or investment losses, in some cases significantly.
- ◆ **Interest Rate Risk** When interest rates rise, bond values generally fall. This risk is generally greater the longer the maturity of a bond investment and the higher its credit quality.
- ◆ **Investment Leverage Risk** Investment Leverage occurs when the economic exposure is greater than the amount invested, such as when derivatives are used. - ◆ **Liquidity Risk** Liquidity Risk is the risk that a Fund may encounter difficulties meeting its obligations in respect of financial liabilities that are settled by delivering cash or other financial assets, thereby compromising existing or remaining investors.
- ◆ **Operational Risk** Operational risks may subject the Fund to errors affecting transactions, valuation, accounting, and financial reporting, among other things.

Charges
