

## Definitions

Sharpe ratio: A risk-adjusted measure, calculated using standard deviation and excess return to determine reward per unit of risk. The higher the Sharpe ratio, the better the fund's historical risk adjusted performance. **Treynor ratio**: Measure of risk adjusted portfolio performance where Beta acts as a proxy for the level of risk associated with a given portfolio. **Tracking error**: Dispersal of differences between the returns obtained by the Fund and the benchmark variation. **Information ratio**: The ratio of annualized expected residual return to residual risk. **Risk adjusted alpha**: Measures the difference between a fund's actual returns and its expected performance, given its level of risk as measured by beta. **Beta**: Measures the sensitivity of the fund to the movements of its benchmark. **R-Squared**: Measures the strength of the linear relationship between the risk dat a given portfolio risk, the Modigliani ratio serves to adjust for the risk that a given portfolio takes in excess of the risk-free rate. **Standard deviation**: Measures the risk or volatility of an investment's return over a particular time period; the greater the number, the greater the risk.
