Objectives and investment policy

This actively managed sub-fund aims to achieve the highest possible capital growth over the long term. It is categorized as Article 8 SFDR.

- It mainly invests in equities and equity-like securities. It may invest up to 20% via Shanghai-Hong Kong Stock Connect and Shenzhen-Hong Kong Stock Connect in China A-Shares. It may also hold cash.
- The sub-fund mainly invests in equities and equity-like securities issued by companies worldwide that operate in future resources sector that includes the main themes of alternative energy (e.g. wind and solar energy, biofuel) and resource scarcity (such as raw materials, product innovation, clean water, forestry, agriculture etc.).
 Type of approach: The Sub-Fund promotes environmental and social characteristics by following exclusions and ESG integration approaches. In addition, companies must have a minimum ESG rating (i.e. excluding the worst ESG laggards) based on the scoring model of a renowned third party data provider. This ESG rating evaluates companies on specific environmental, social and governance criteria. By focusing on the theme of the ongoing transition from carbon to renewable energy and applying the ESG criteria as described above, the Sub-Fund excludes at least 20% of

the initial investment universe, namely the equity market worldwide. **Threshold**: At least 90% of the securities in the Sub-Fund are covered by the ESG analysis. The Sub-Fund applies a comprehensive voting and engagement strategy via a third-party provider that enables it to use its role as shareholders (and prospective shareholders) to support companies in becoming more sustainable. **Main methodological limits:** potential inconsistency, inaccuracy or lack of availability of ESG data issued by external third party providers. **More details on the above can be found in the prospectus**.

- The sub-fund may use derivatives to achieve the investment objective and for hedging purposes.
- The sub-fund is not managed with reference to a benchmark. The portfolio manager has full investment discretion within the predefined investment limits.
- Income may be paid out each year.
- Buying and selling securities entails transaction costs payable in addition to the charges listed.
- Redemption of shares: daily when banks in Luxembourg are open for normal business (see prospectus for details and exceptions).

When assigning a sub-fund's share class to a risk category, it may be the case that not all risks are taken into account. Such risks include risks in connection with exceptional market events, operational errors, legal and political events. You can find a detailed list of the risks in the "Notice regarding special risks" section in the general part of the sales prospectus. The following risks have no direct influence on this category, but may still be important:

- Using derivatives generally creates leverage and entails valuation risks and operational risks. Leverage magnifies gains but also losses. Over-the-counter derivatives involve corresponding counterparty risks.
- The portfolio has lower risk diversification as the focus lies on companies within a specific investment theme.
- The sub-fund also includes sustainability criteria in its investment process. This may mean that the sub-fund's performance is more positive or negative than a conventionally managed portfolio.
- Investments in China A-Shares are subject to changes in political, economic and social conditions in China as well as changes in the policies of the PRC government, laws and regulations.
- A company's stock price may be adversely affected by changes in the company, its industry or economic environment and prices can change quickly. Equities typically involve higher risks than bonds and money market instruments.


