INVESTMENT OBJECTIVE

Santander Corporate Coupon generates returns through corporate bonds from different sectors and issuers, including investment grade and non-investment grade securities. The Sub-Fund invests mainly in US and EU Corporate Investment Grade fixed income, and, to a lesser extent, from other regions as OECD countries. The Fund can hold up to 50% in high quality tranches of High Yield debt (rated BB/B) and no more than 10% of this Sub-Fund's portfolio will be rated below B-. It intends to pay a half-yearly or annual dividend. Derivatives may be used to reduce risk or as a part of the investment strategy.

MONTHLY STRATEGY

It was a good month for credit in the US, despite spreads widening by 13bp (OAS Govt), offset by interest rates moving sharply to the downside. The escalating trade war between the US and China plus threats of fresh tariffs on Mexico increased the probability of interest rate cuts this year from 67% in April to 95%. The fund ramped up duration and is now positioned in line with its benchmark.
