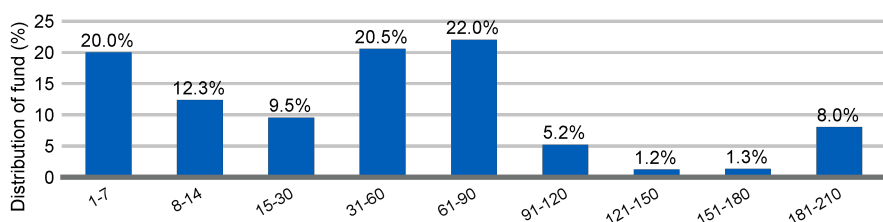
Investment Objective

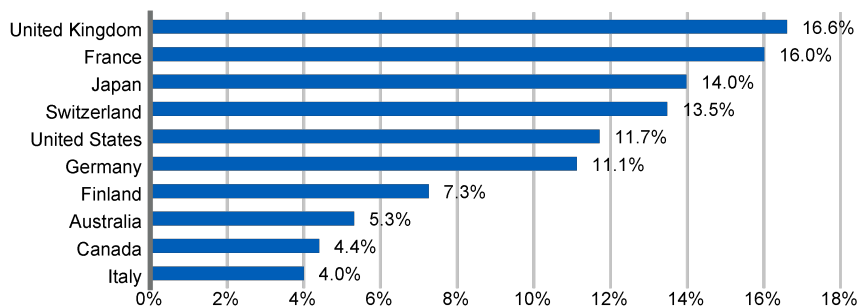

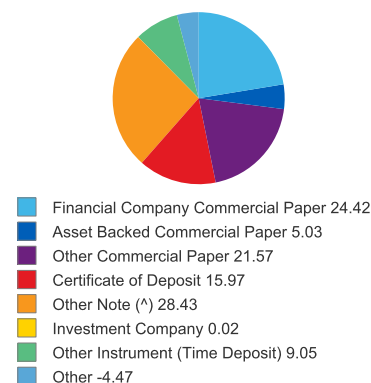

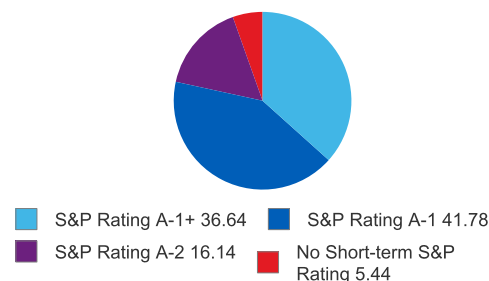

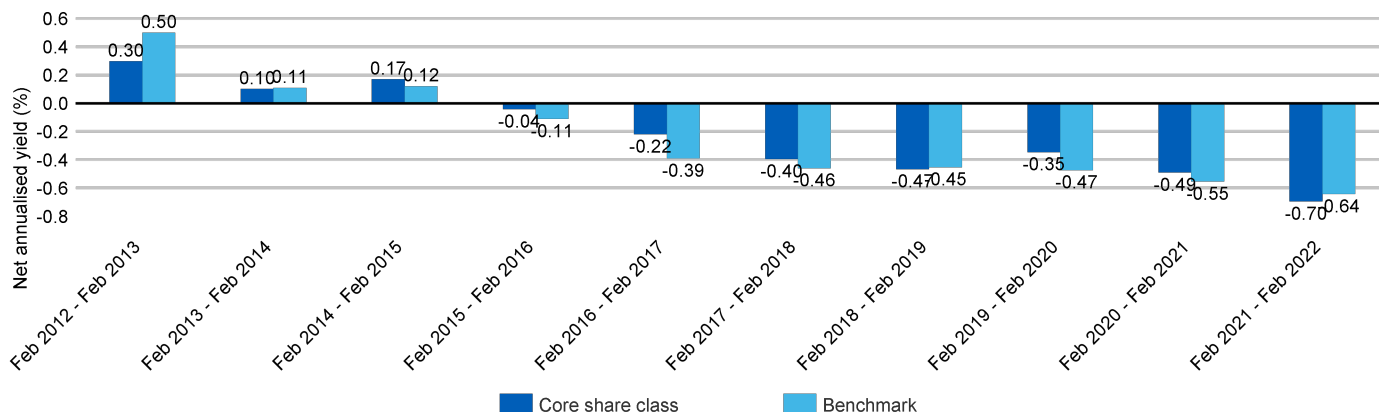

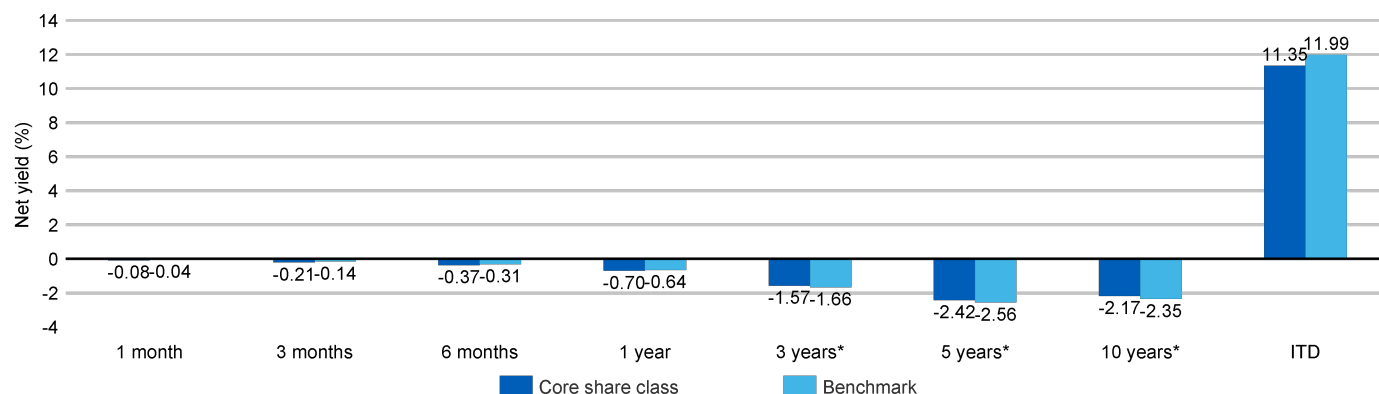

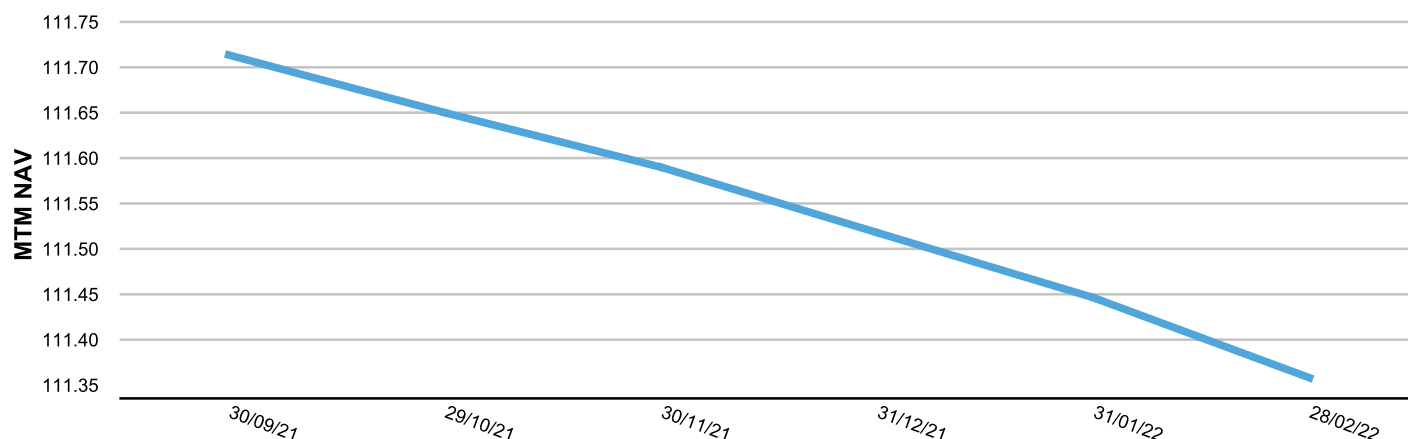
