#### **INVESTMENT STYLE & OBJECTIVE**

Quaero Capital Funds (Lux) – Argonaut invests in small and micro caps listed on European stock markets. The Fund focuses on little-known or poorly followed smaller companies and situations that have been ignored by mainstream investors. The investment process is based on in-depth fundamental research head nimes out of format fundamental research through direct contact with company management and primary extra-financial analysis. The Fund applies a rigorous "Value Investing" philosophy with a wilfully open mind, aiming to ensure a "margin of safety", with the intention to accumulate a portfolio of 'good' companies acquired at 'great' prices. With significant minority stakes, the managers apply 'constructive engagement' to 'encourage best practice' on portfolio companies to further enhance performance, improve ESG metrics and shape the exit strategy.






