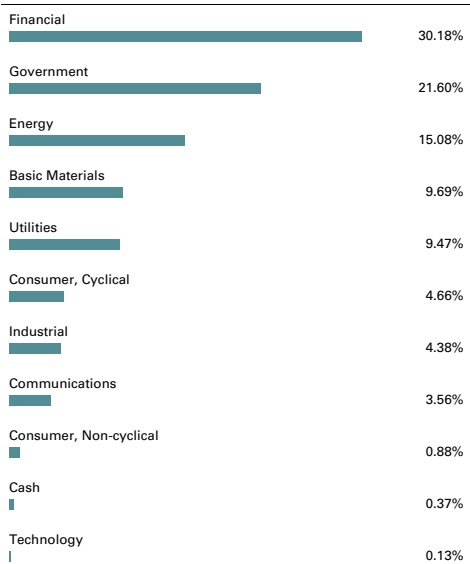

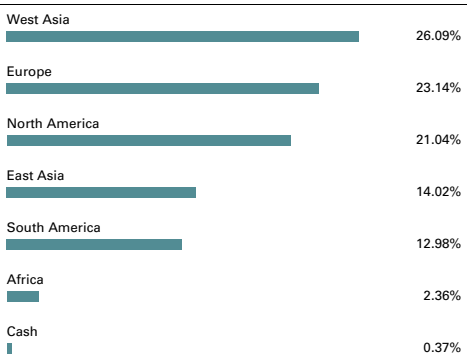
Bloomberg Sector Allocation

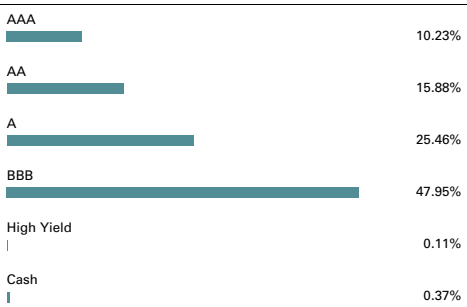
Regional Allocation

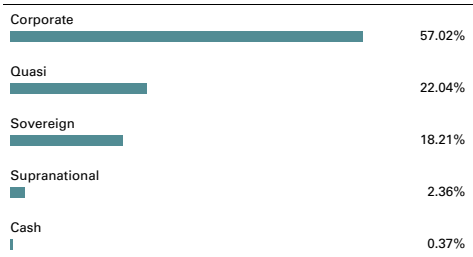
Credit Allocation

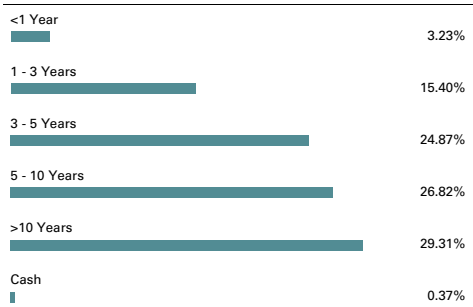
Entity Allocation
