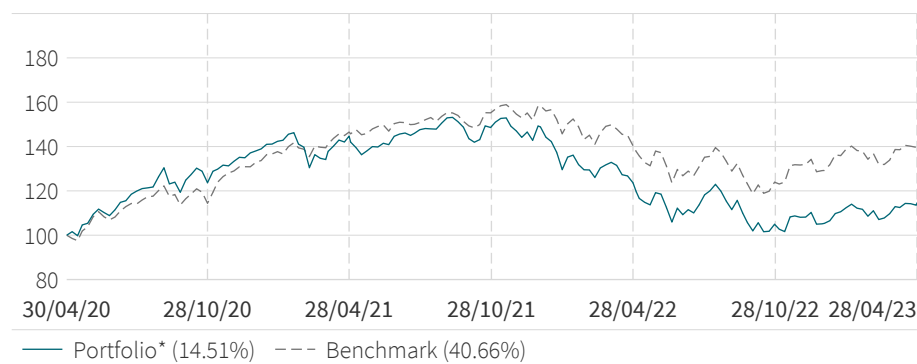

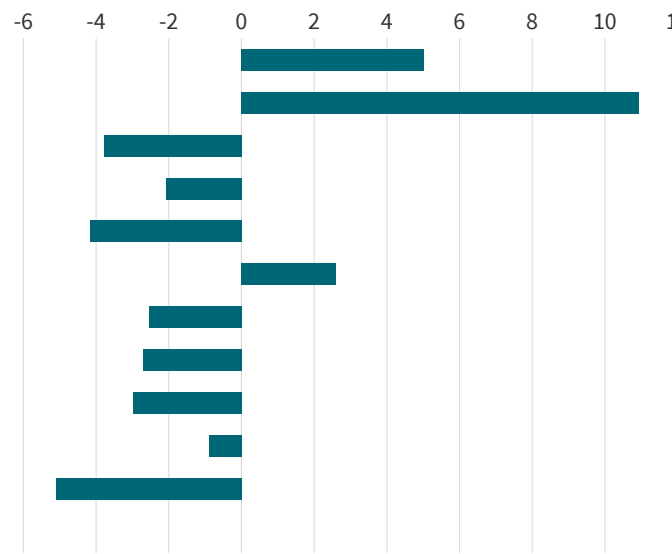

Active Exposure by Sector (%)

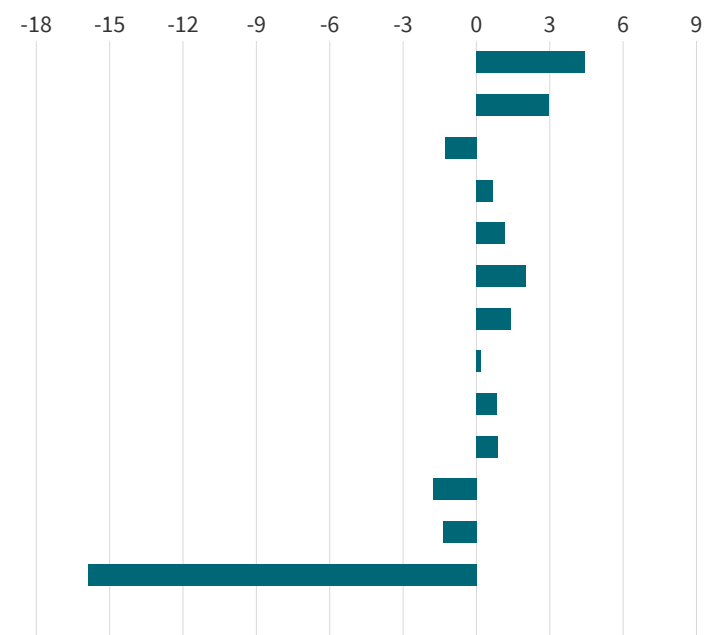

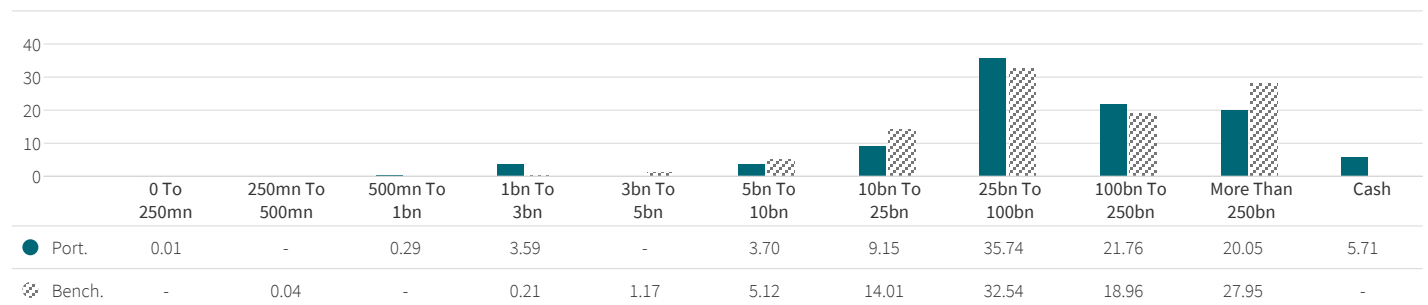

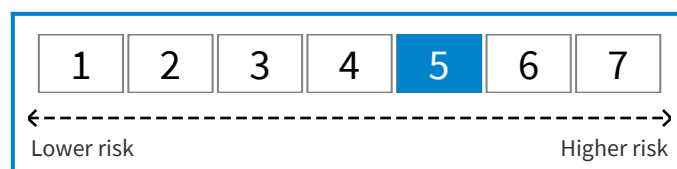
