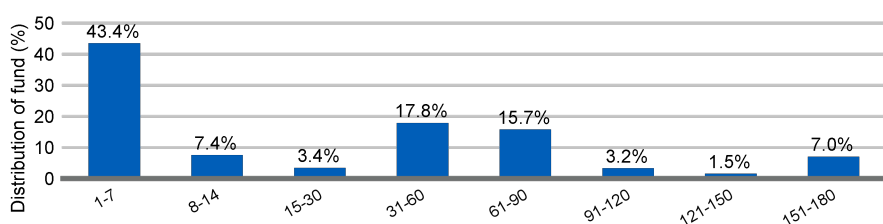
Investment Objective

Investment Policy

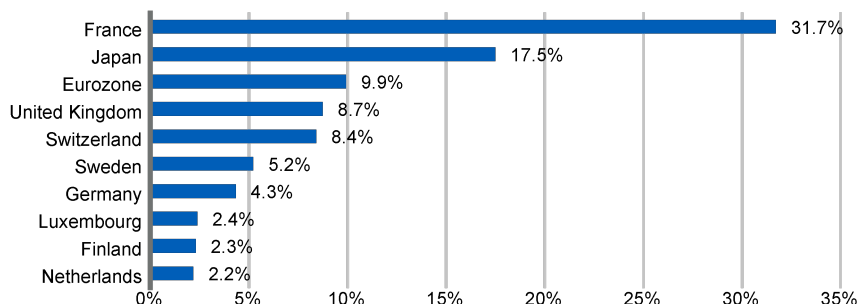

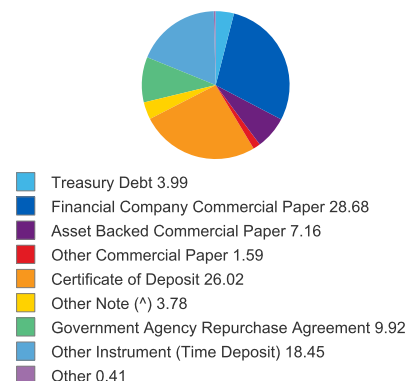

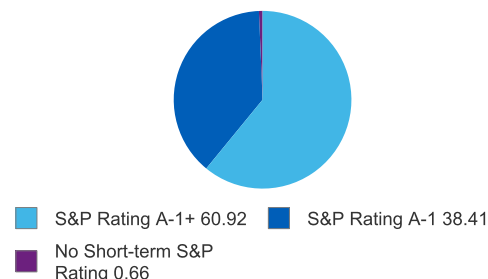

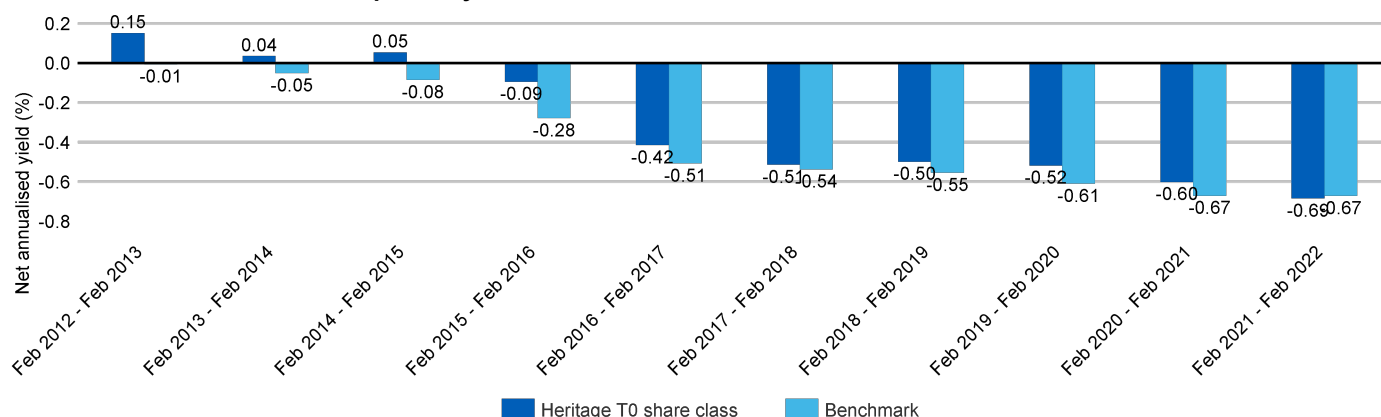

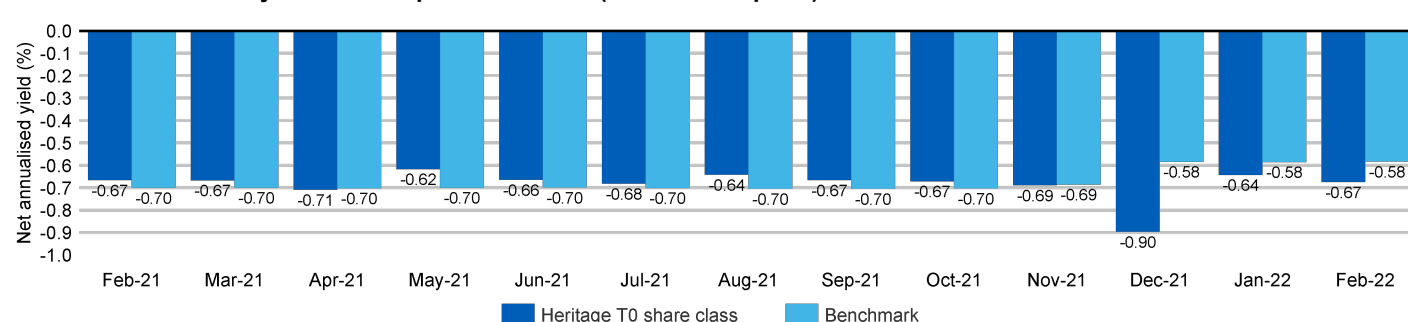

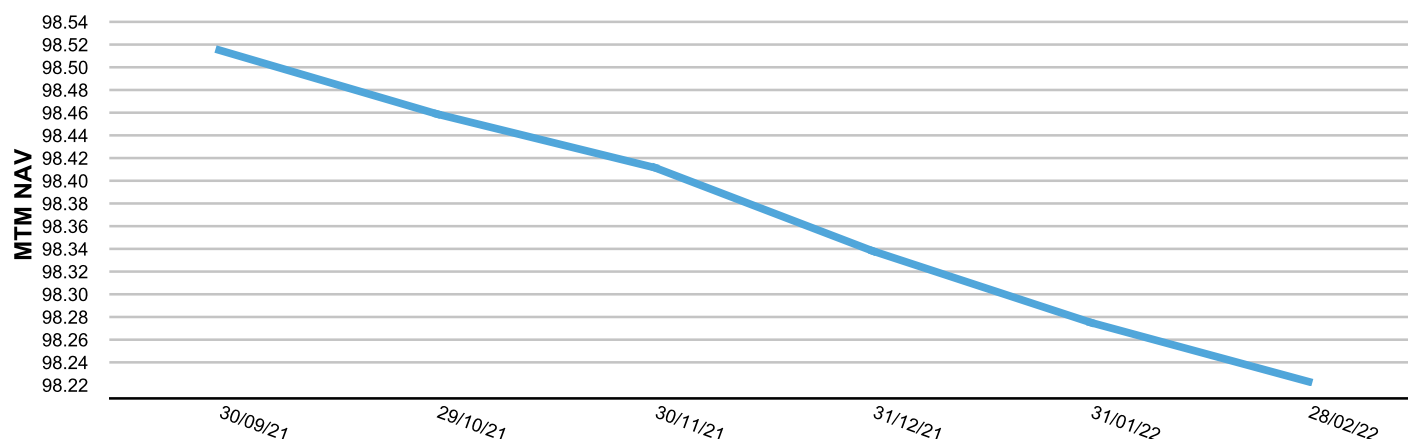
