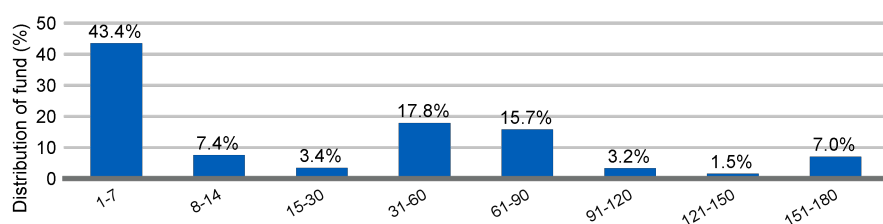
Investment Objective

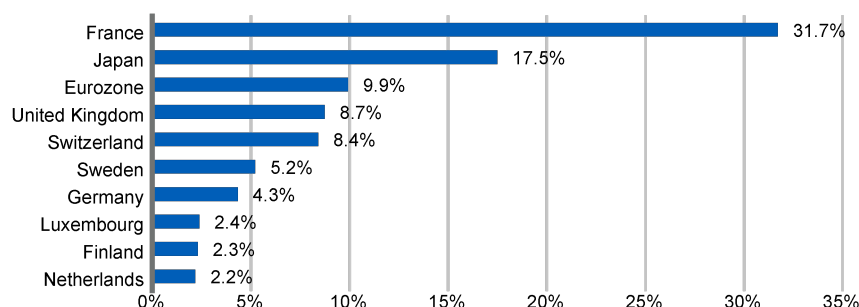

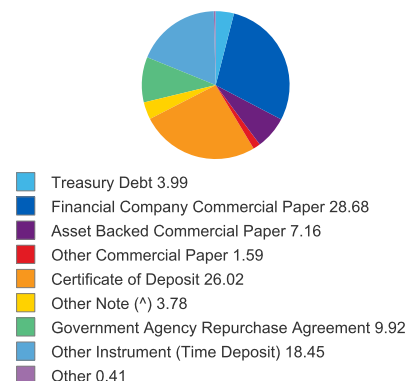

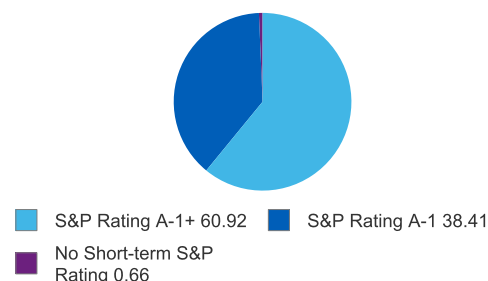

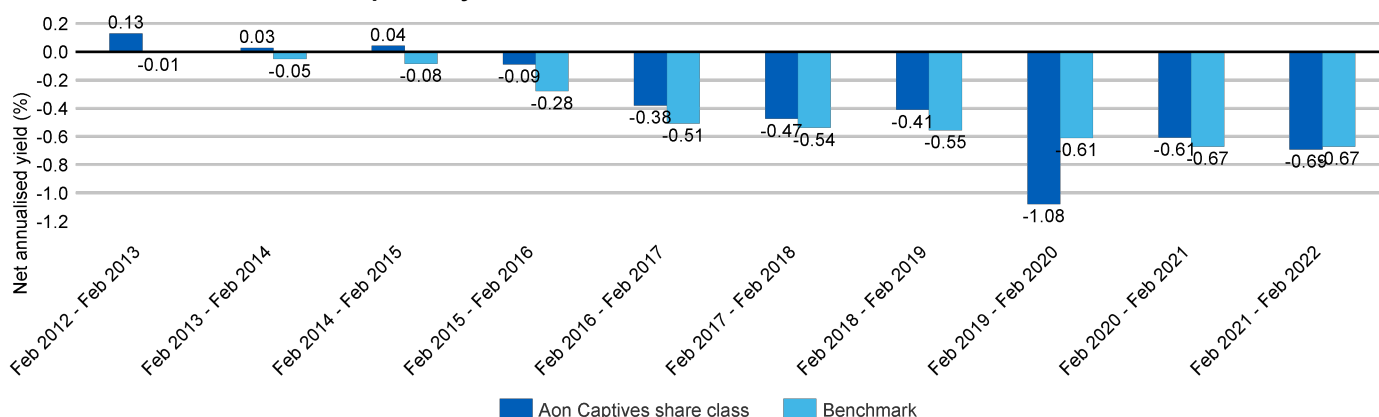

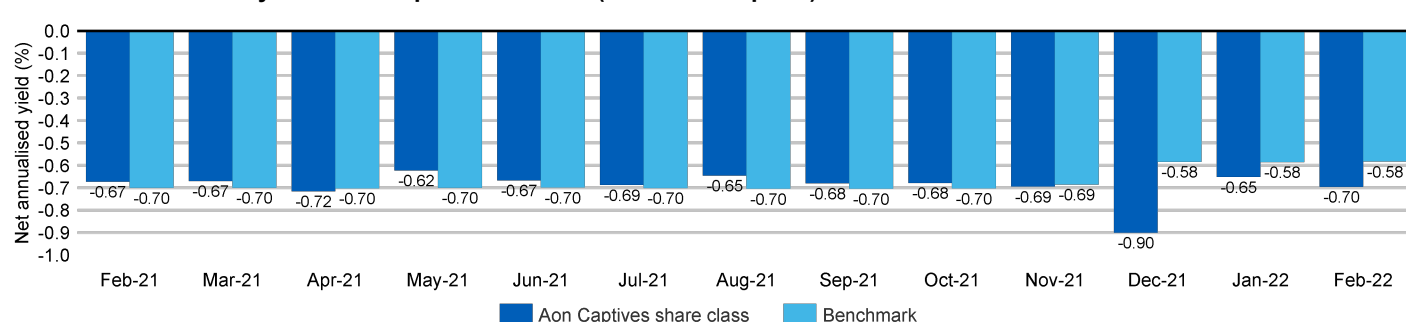

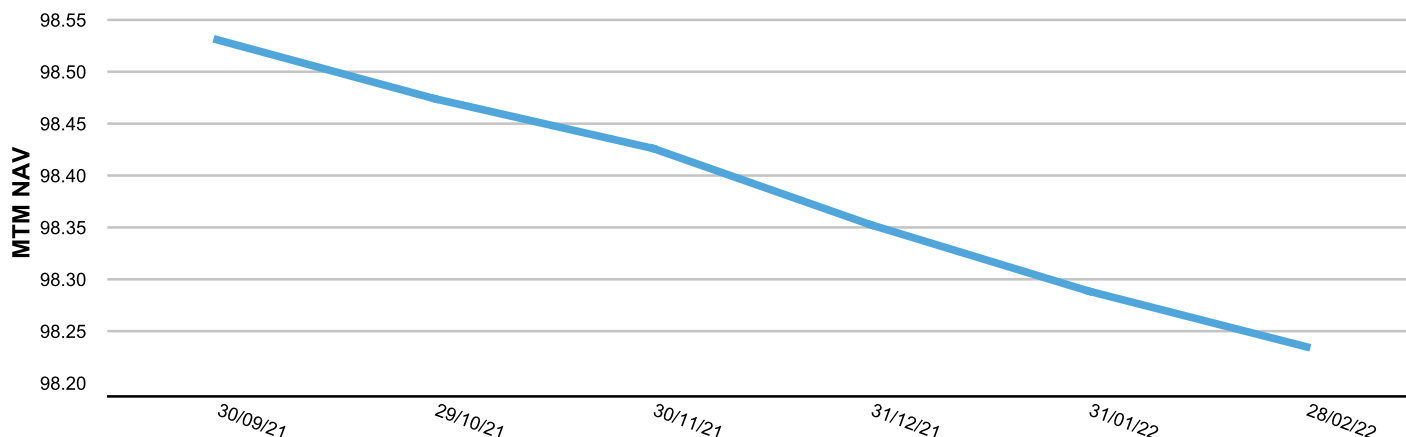
