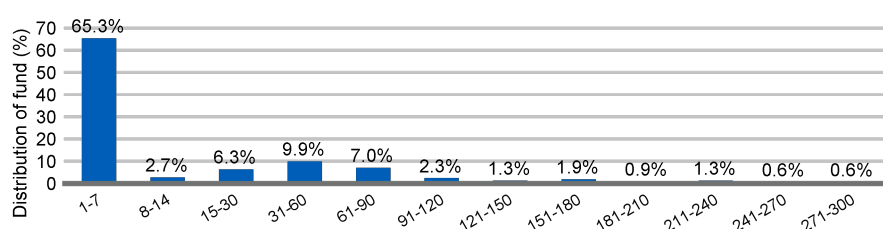
Investment Objective

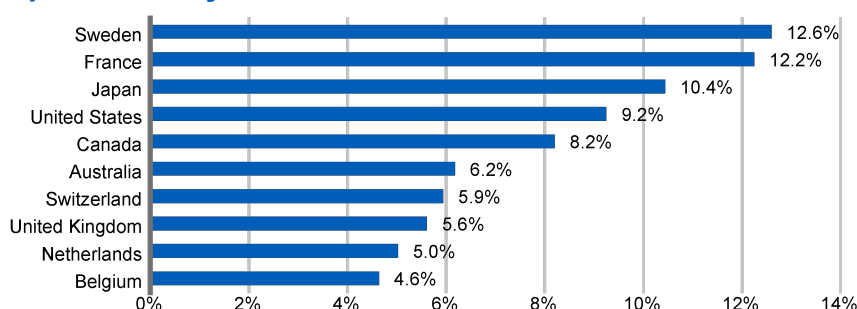

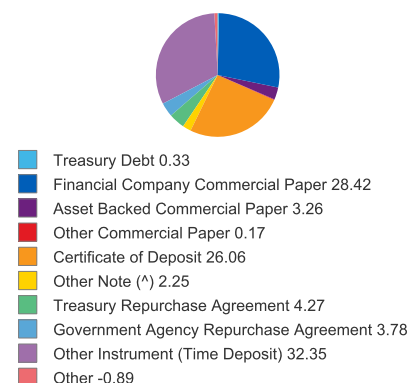

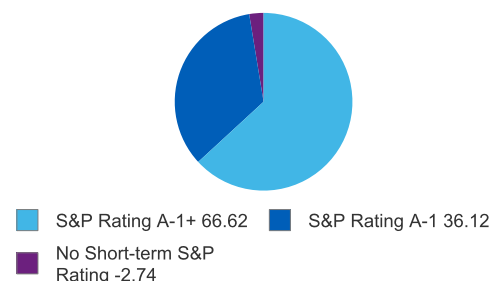

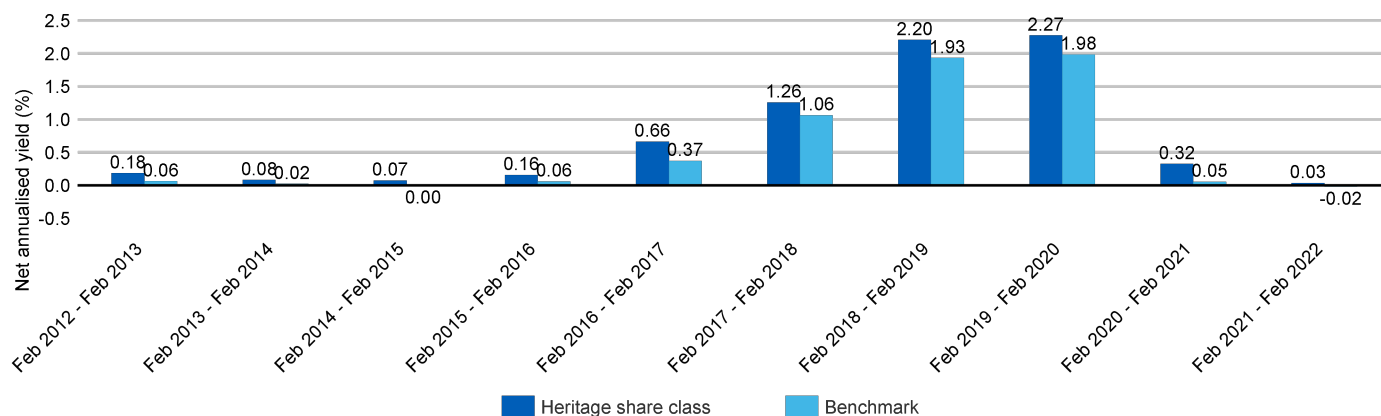

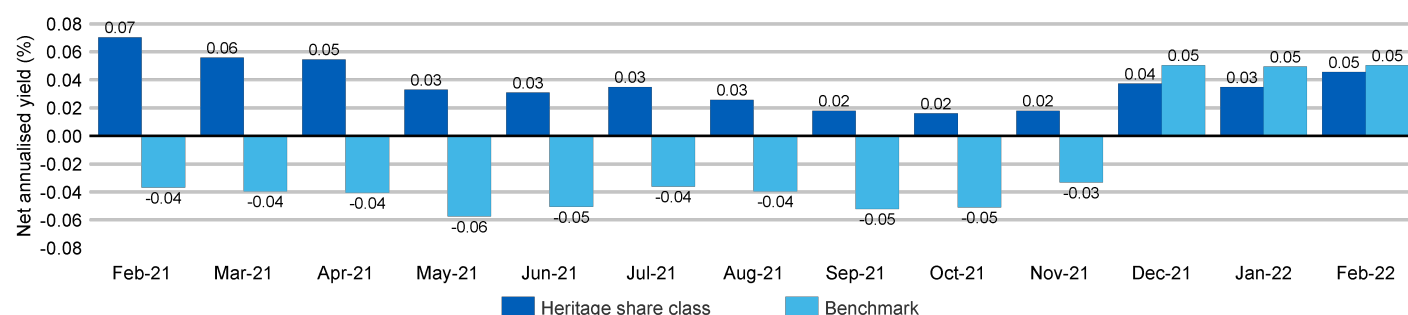

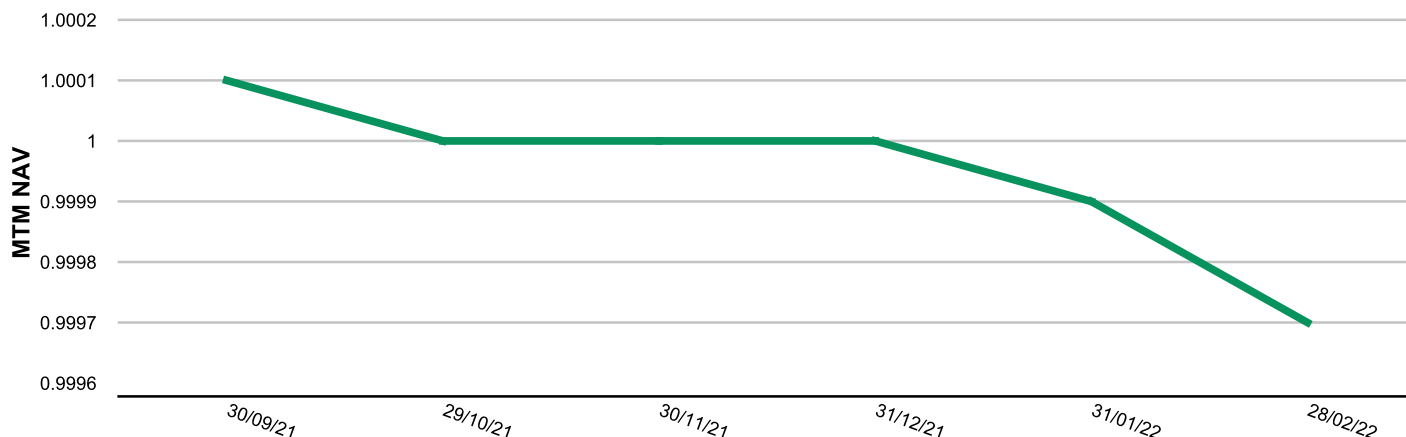
