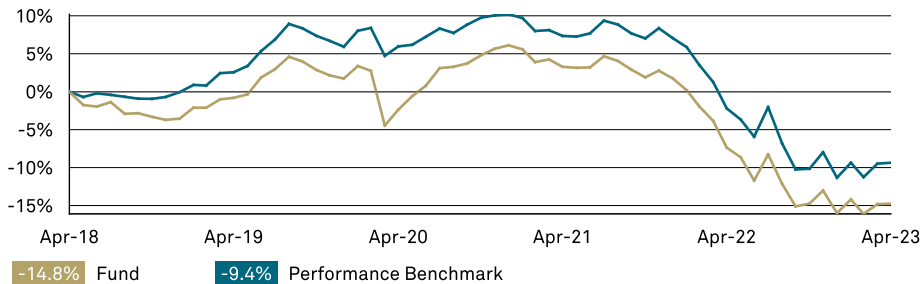
## INVESTMENT OBJECTIVE

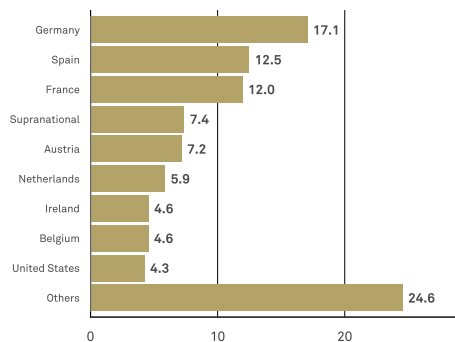

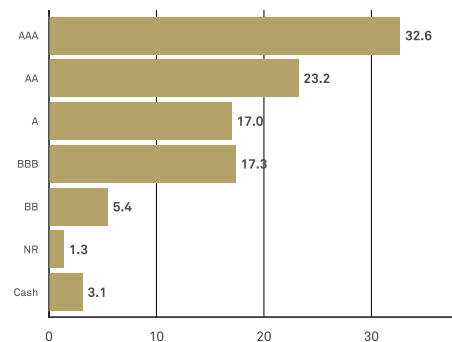

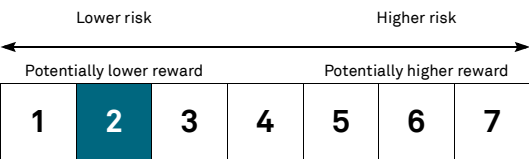
