OBJECTIVES AND INVESTMENT POLICY

Investment objective

The Fund seeks to increase the value of your investment over the long term.

Investment policy

Under normal circumstances, the Fund invests mainly in equities of companies that are based in, or carry out most of their economic activities in, Eurozone countries. It aims to identify securities that it believes are attractively priced relative to their potential for future earnings.

The Fund may use derivatives (i) to gain additional exposure, (ii) for efficient portfolio management and (iii) in seeking to reduce potential risks.

Fund currency

The reference currency of the Fund is EUR.

Share class currency

The reference currency of the share class is EUR.

Distribution policy

This share class is a non-distributing share class. Income and capital gains derived from the Fund are reinvested.

Redemption

Shares may be redeemed on any day when both the New York Stock Exchange and Luxembourg banks are open for business.

Terms to understand

Derivatives: Financial instruments whose value is linked to one or more rates, indices, share prices or other values.

Equities: Securities that represent an ownership stake in a company.

Eurozone countries: Countries that are member states of the European Union and have adopted the Euro as their sole currency.

What does this risk indicator mean?
