Objectives & Investment Policy

The aim is to increase the value of your investment and to earn income within the Fund.

The Fund is actively managed and invests mainly in multicurrency tradable debt (such as bonds and notes), money market instruments (a range of short-term financial products which can be easily bought and sold on money markets), preferred shares and convertible securities (tradable debt which can be converted into shares), with variable repayment terms and interest rates, issued by government, other public bodies and companies based in emerging market economies. The Fund may use financial contracts (derivatives) to help achieve its aim and to manage risk, reduce costs and improve results

Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within 5 years.

Income is not paid out and is rolled up (accumulated) into the value of your investment.

You may sell your investment on a daily basis.

Risk and Reward Profile


