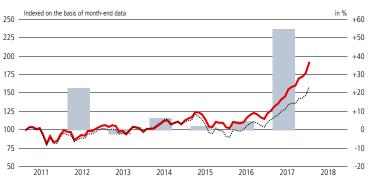
- Equity fund focused on active stock selection, sector and country allocation within Asia.
