Fund Description

The PIMCO Unconstrained Bond Fund is an absolute return-oriented, investment-grade bond strategy that is not tethered to benchmark-specific guidelines or significant sector constraints. The fund utilizes PIMCO's global secular forecast and an integrated investment process across multiple sectors with a duration that may range from -3 to +8 years.

This fund offers attractive risk-adjusted return, active downside risk mitigation and strong diversification within an overall portfolio context.

The fund's broader investment discretion to adjust duration exposure, allocate across sectors and express other active views offer attractive risk-adjusted return.

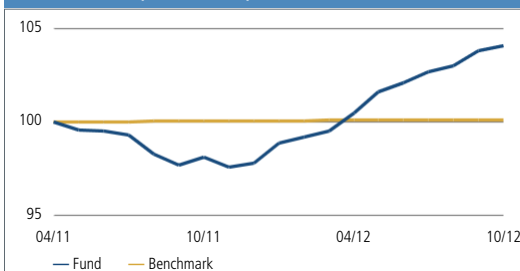

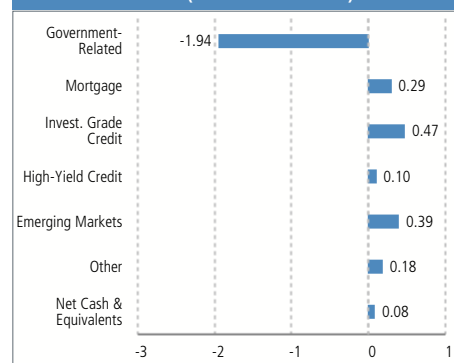

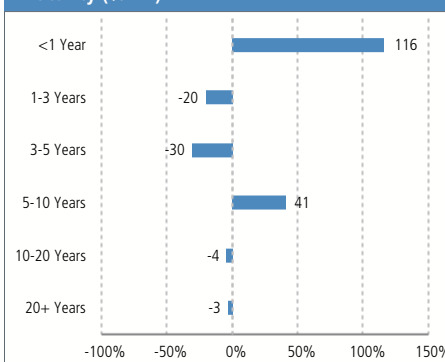

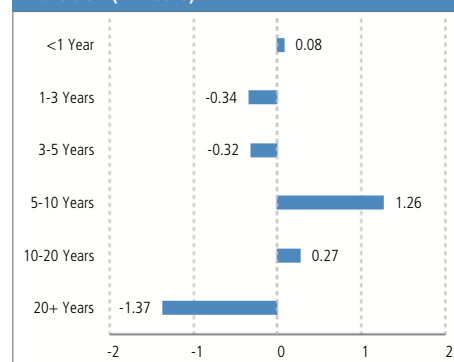
Sector Allocation (Duration in Years)

Duration (in Years)

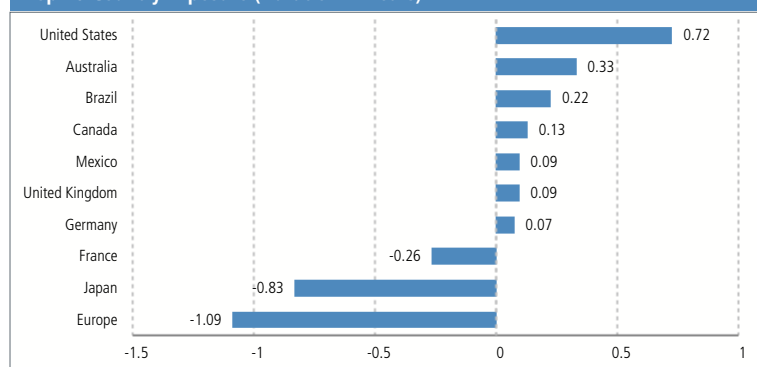

Unconstrained Bond Fund CHF (Hedged)

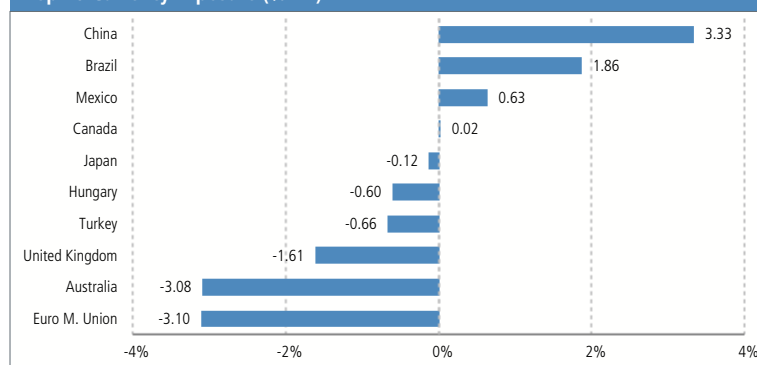
