Objective



The Fund aims to outperform the Bloomberg Global Aggregate Corporate Bond Index (Hedged to USD) benchmark (before charges).

Portfolio securities

- The Fund invests at least 80% of its assets in investment grade bonds issued by corporations.
- The Fund may also invest in government bonds, sub-investment grade debt and other interest bearing securities issued anywhere in the world.
- Non-US Dollar denominated issues will typically be hedged back to US Dollars.
- The Fund may also invest in other transferable securities, money-market instruments, deposits, cash and near cash, derivatives (including currency forwards, interest rate and credit default swaps) and collective investment schemes.

- The Fund is actively managed.
