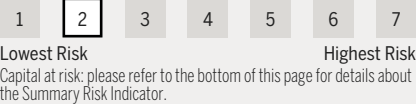

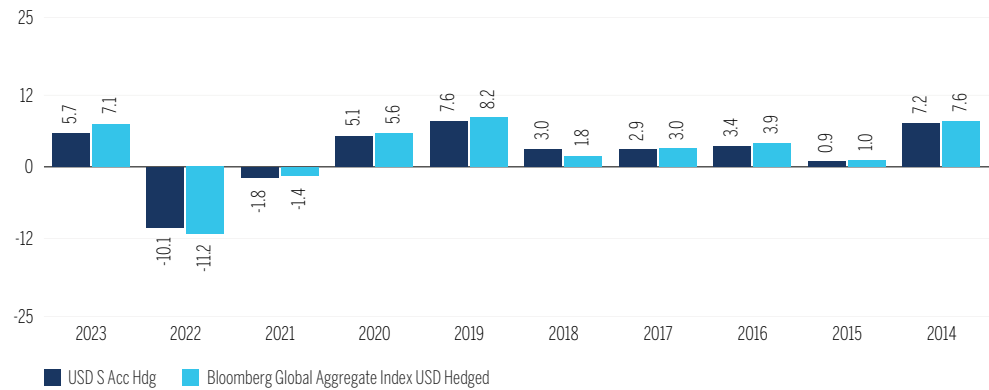

WHAT ARE THE RISKS?

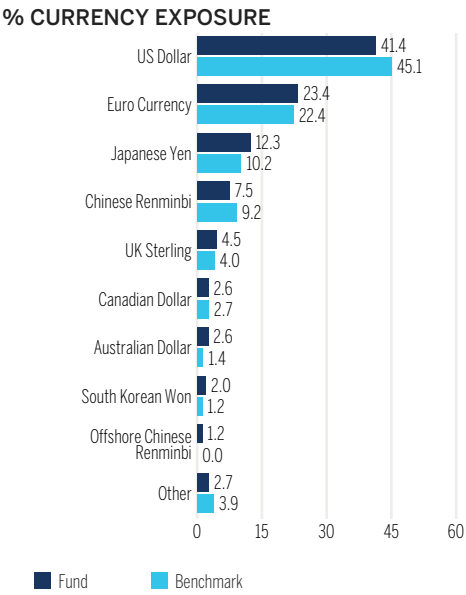

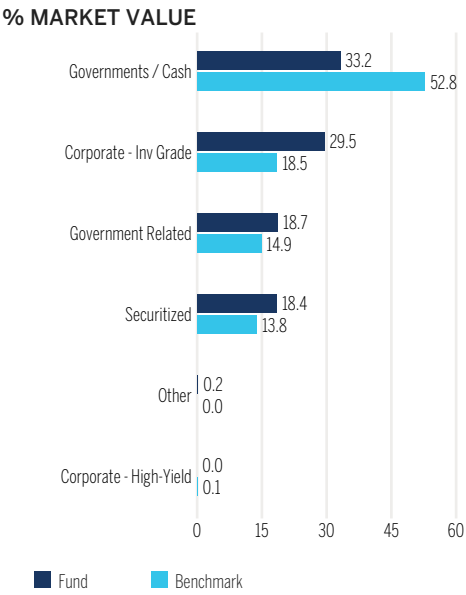

CURRENCY EXPOSURE



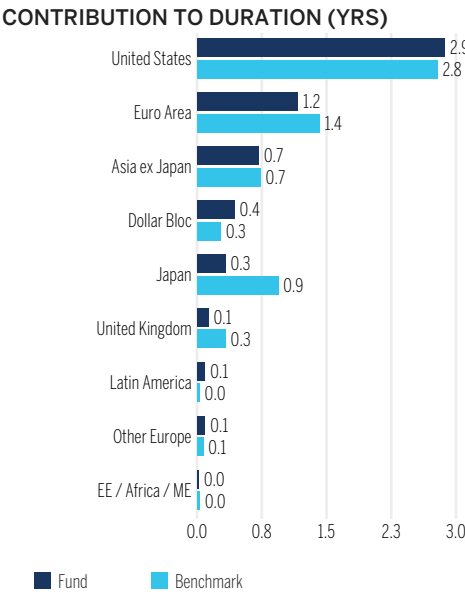

SECTOR DISTRIBUTION



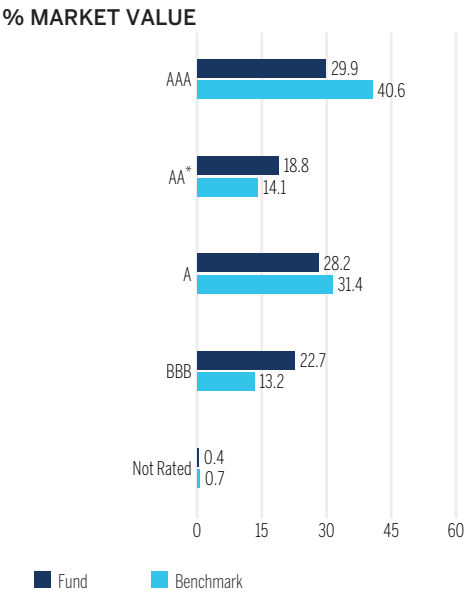
