Objectives and investment policy

The aim of the Fund is to provide capital growth by investing primarily in a diversified portfolio of emerging markets companies around the world. Emerging markets are typically countries that are still developing their economies.

The Investment Manager will choose well-managed, large and medium sized companies, with a market capitalization of at least \$3 billion, which it believes to have above-average growth, profitability and quality characteristics. The Fund is measured against a benchmark, which is the MSCI Emerging Markets Index (net).

Any income generated by the Fund is reinvested to grow the value of your investment.

Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within 5 years.

You can buy and sell shares in the Fund on a daily basis on any full working day in Luxembourg when the New York Stock Exchange is open for trading.

Risk and reward profile

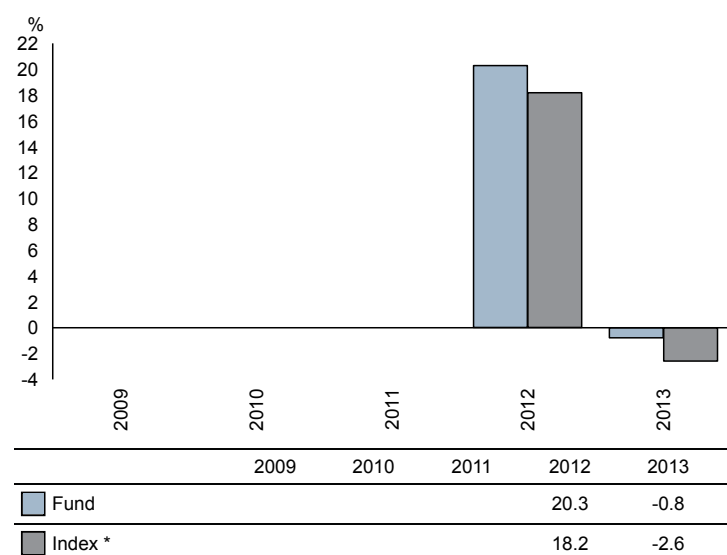
