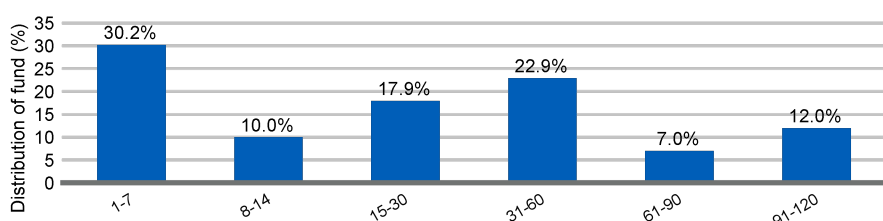
### Investment Objective

### Investment Policy

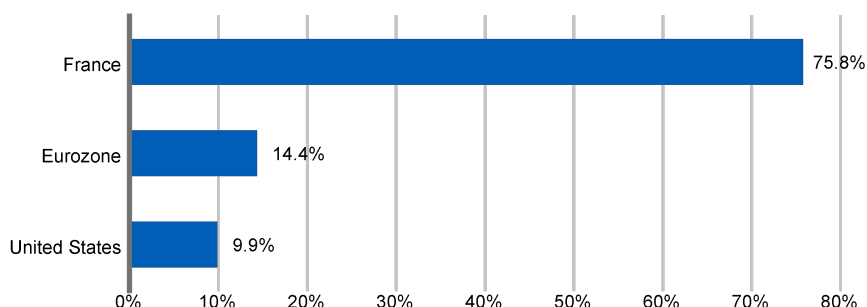

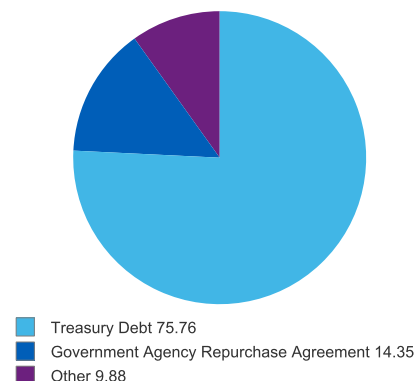

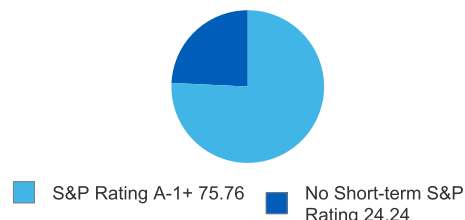

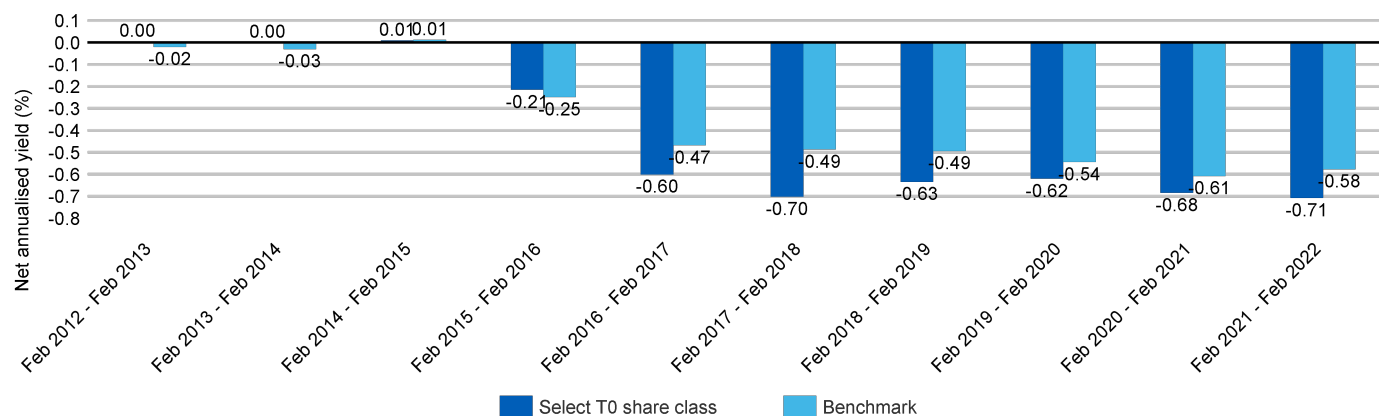

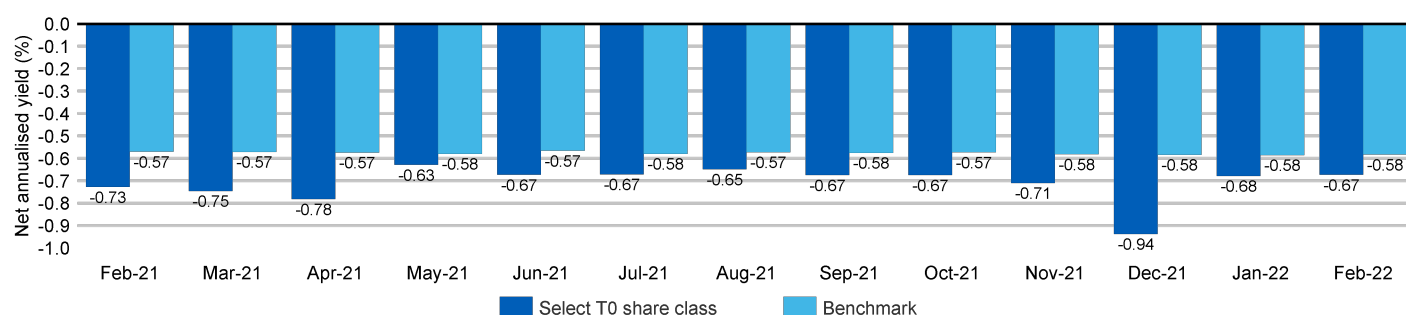

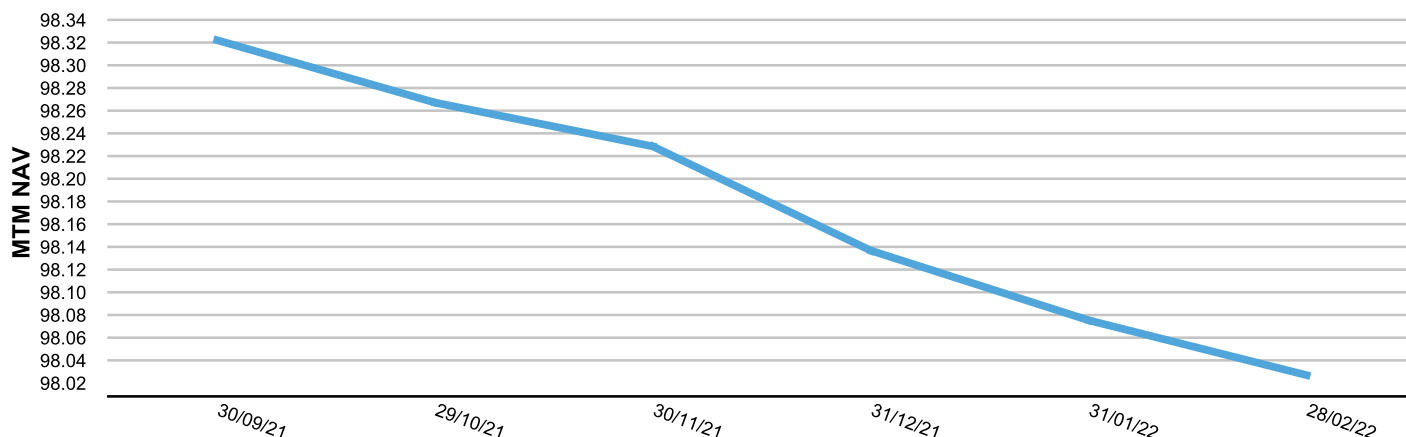
