The Fund aims to provide long term capital growth and income by investing in a diversified portfolio of shares and securities similar to shares.




# Investment strategy

The Fund may invest at least 51% of its assets in shares. The Fund may also invest up to 10% of its assets in other funds, including HSBC funds. ## Main risks




