Objectives and Investment Policy

Investment Objective:

The Fund aims to provide long term capital growth and income by investing in a portfolio of Eurozone shares, while promoting environmental, social and governance (ESG) characteristics. The Fund promotes ESG characteristics within the meaning of Article 8 of SFDR. Investment Policy:

In normal market conditions, the Fund will invest at least 90% of its assets in shares (or securities similar to shares) of companies of any size, that are based in, or carry out most of their business in any European Monetary Union member country. The Fund typically focuses on profitable companies with higher than average reinvestment rates in order to maintain and/or increase their current level of growth.

The Fund includes the identification and analysis of a company's ESG Credentials as an integral part of the investment decision making process to reduce risk and enhance returns. The Fund will not invest in companies with involvement in specific excluded activities, such as: companies involved in the production of controversial weapons and tobacco; companies with more than 10% revenue generated from thermal coal extraction; and companies with more than 10% revenue generated from coal-fired power generation. The Fund conducts enhanced due diligence on companies that are considered to be non-compliant with the UN Global Compact Principles.

ESG Credentials, Excluded Activities and the need for enhanced due diligence will be identified and analysed using both HSBC's proprietary ESG Materiality Framework as well as research & expertise from well-established financial data providers. Why is this Fund in this specific category?

This Fund is classified in category 6 because its price or simulated data has shown high fluctuations historically.

Material risks not fully captured by the Risk and Reward Indicator:

 Counterparty Risk The possibility that the counterparty to a transaction may be unwilling or unable to meet its obligations. The Fund may invest up to 10% of its assets in Real Estate Investment Trusts (REITs), up to 10% in other funds and may invest in bank deposits, money market instruments for treasury purposes. The Fund may also invest in derivatives and use them for hedging, efficient portfolio management purposes and cash flow management purposes. Derivatives will not be used extensively for investment purposes. Derivatives may also be embedded in other instruments used by the Fund.

- The Fund may enter into securities lending transactions for up to 29% of its assets. However, this is not expected to exceed 25%.
- The reference currency of the Fund is EUR. The reference currency of this share class is EUR.
- The Fund is actively managed and does not track a benchmark. The Fund has an internal or external target to a reference benchmark, MSCI EMU Net.
- The Investment Advisor will use its discretion to invest in securities not included in the reference benchmark based on active investment management strategies and specific investment opportunities. It is foreseen that the reference benchmark will not be used as a universe from which to select securities.
- The deviation of the Fund's performance and underlying investments' weightings relative to the benchmark are monitored, but not constrained, to a defined range.
- Income is reinvested.
- You may sell your investment on most working days.
- Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within a period of 5 years.


The charges you pay are used to pay the running costs of the Fund, including the marketing and distribution costs. These charges reduce the potential growth of the investment.
