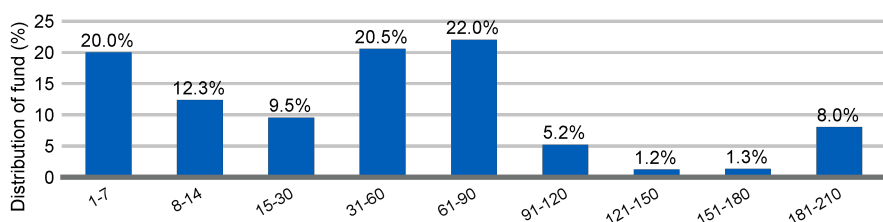
### Investment Objective

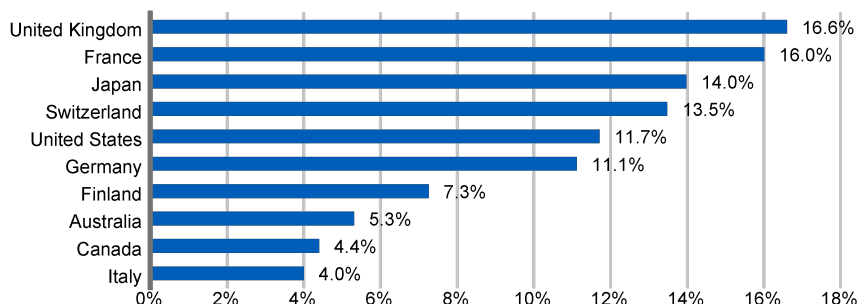

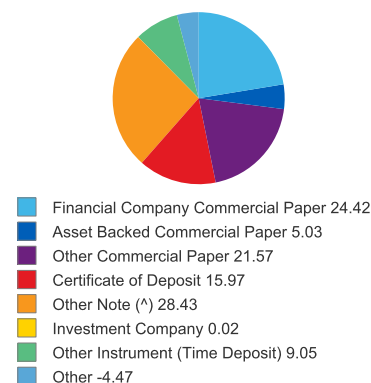

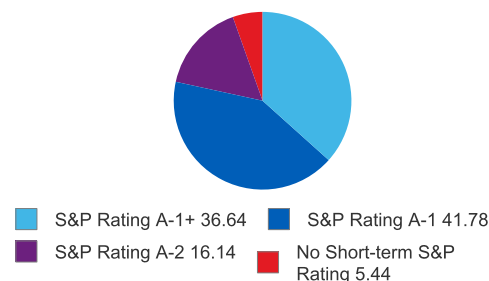

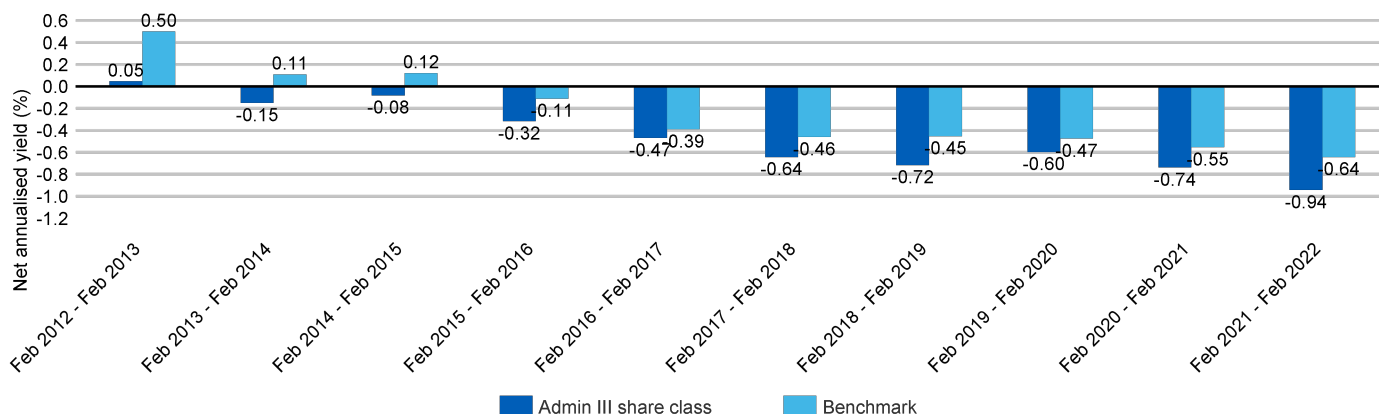

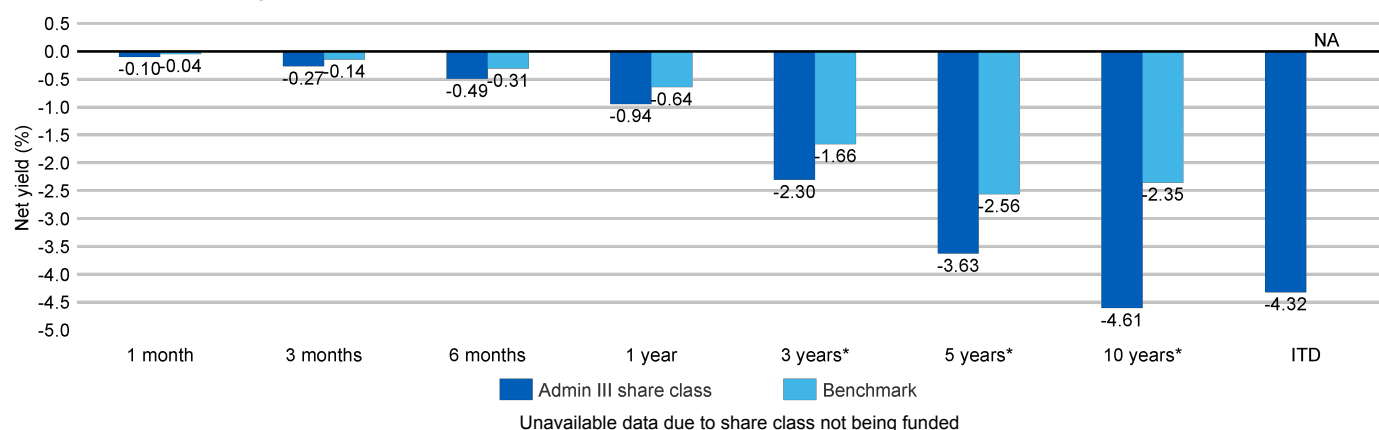

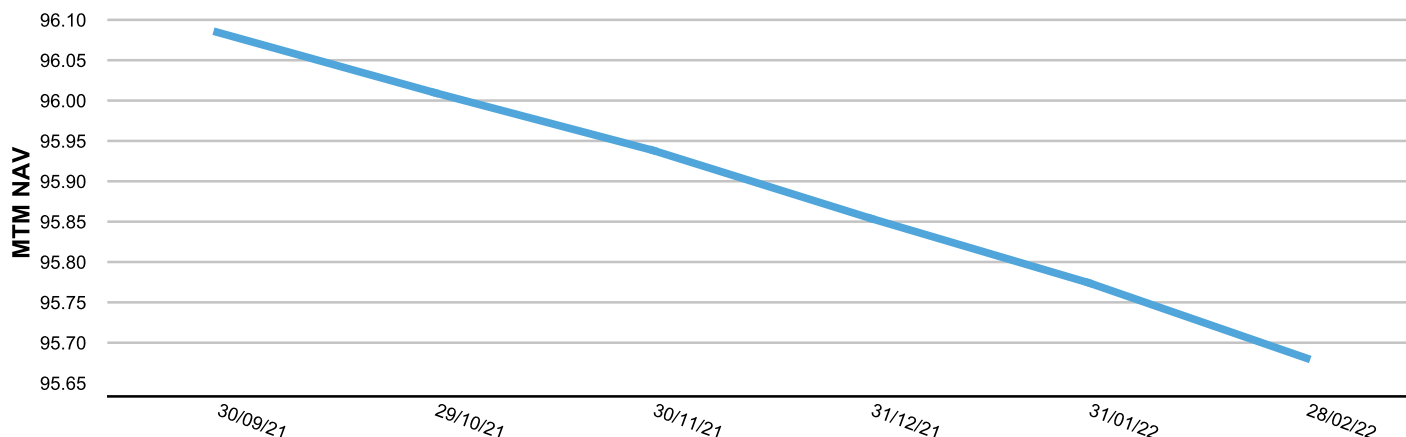
