



Overall Impact On: People







On 01.01.2024 Anna Podoprigora & Ingmar Przewlocka replaced Ingmar Przewlocka as Fund Managers. Since its adoption on 16 August 2022 the comparator benchmark was displayed as the Morningstar EUR Cautious Allocation – Global Category. However, this was intended to be the Morningstar EUR Cautious Allocation – Global Category Median, as applied in practice from that date. Schroder ISF Global Dynamic Balanced was launched in July 2012 to accommodate a transfer of shareholders from the Strategic Solutions funds to the Schroder ISF SICAV. On 01.06.2016, the Fund, previously named Schroder ISF Global Dynamic Balanced, changed its name to Schroder ISF Global Multi-Asset Balanced. Prior to 02.07.2012 the fund uses the track record of the Strategic Solutions - Schroders Global Dynamic Balanced Fund (launched on 28.08.2009) as a performance track record.

Benchmarks: (If applicable)

Some performance differences between the fund and the benchmark may arise because the fund performance is calculated at a different valuation point from the benchmark. The fund is not managed with reference to a benchmark. The comparator benchmark has been selected because the investment manager believes that the benchmark is a suitable comparison for performance purposes given the fund's investment objective and policy.

Source and ratings information
