### Objectives and Investment Policy

The aim is to increase the value of your investment over the long-term by investing mainly in US companies.

The Fund is actively managed and invests in shares and convertible securities (tradable debt which can be converted into shares) issued by companies, across a range of industries, based in the US. The Fund has a bias towards larger US companies.

The investment manager has discretion to select the companies it chooses to invest in but does take into consideration the universe of companies represented by the S&P 500 Index (Net Return). While the Index may inform the selection of potential

investments, the overall Fund investments, as well as the performance of the Fund, can differ significantly from the Index.

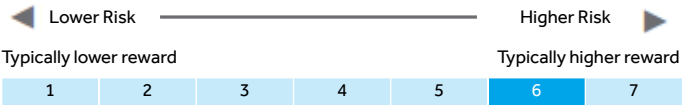
The Fund may use financial contracts (derivatives) to help achieve its aim and to manage risk, reduce costs and improve results.

Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within 5 years.

Income is not paid out and is rolled up (accumulated) into the value of your investment.

You may buy and sell your investment on each business day.

The following risks are materially relevant to the Fund:

The Fund relies upon the performance of one or more investment managers. If the investment managers perform poorly, the value of your investment is likely to be adversely affected.

Future legal or regulatory change could have a substantial adverse effect on the fund and your investment.

The Fund may use derivatives in an attempt to reduce risk (hedging) or for investment purposes. It may be that the use of derivatives causes share prices to fluctuate which may in turn result in loss to the Fund.

The assets in which the Fund invests may be denominated in currencies other than the Fund's base currency. Changes in currency exchange rates can therefore affect the value of your investment.

Your shares will be hedged with the aim of reducing the effect of exchange rate fluctuations between their denominated currency and the base currency of the Fund. This may not completely eliminate currency risk and therefore any residual risk may affect the performance of your shares.

If you purchase shares in the Fund through a clearing or settlement system, you will be bound by its terms and conditions, which may include the payment of additional fees.

The Fund may be exposed to stock market movements in a single country or region which may be adversely affected by political or economic developments, government action or natural events that do not affect a fund investing in broader markets.

Stock markets can be volatile, meaning that the prices of shares held by the Fund can change quickly and substantially.

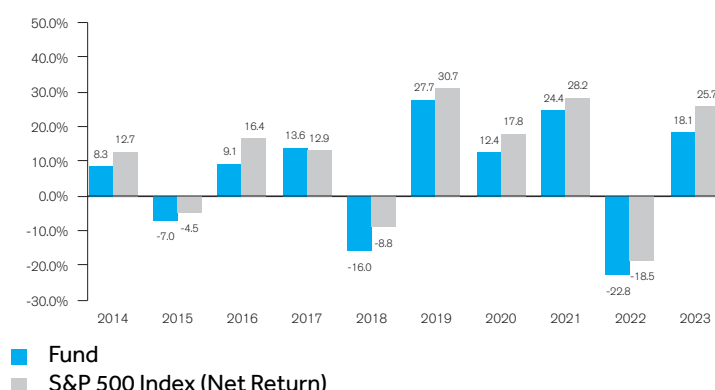

Index returns represent those of Russell 1000 Value Index (Net Return) up to 31 July 2018, and of S&P 500 Index (Net Return) from 1 August 2018. Some periods may therefore comprise a combination of both indices.

Past performance has been calculated in EUR, whilst past performance of the index has been calculated in USD.
