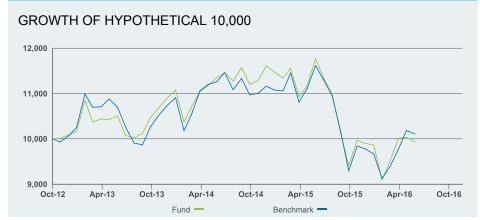

Quartile Rank: categorises a fund into four equal bands based on their performance over a specified period within the relevant Morningstar's sector.
