Objectives & Investment Policy

The aim is to increase the value of your investment over the longterm by investing mainly in European companies (excluding UK companies).

The Fund is actively managed and invests in shares and convertible securities (tradable debt which can be converted into shares) issued by companies based in and traded on stock exchanges in Europe (but not those based in the UK).

The Fund may use financial contracts (derivatives) to help achieve its aim and to manage risk, reduce costs and improve results.

Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within 5 years.

Income is not paid out and is rolled up (accumulated) into the value of your investment.

You may sell your investment on a daily basis.


