Objectives and Investment Policy

The Fund aims to increase the value of your investment over the long term by actively managing its portfolio and mainly investing in (i) shares of companies in Latin America; (ii) shares of companies, from any country, which carry out most of their business in Latin America; and (iii) other financial instruments which provide exposure to these shares.

On a secondary basis, the Fund may also invest in cash, debts issued by companies, governments or other entities and in investments which can be easily converted into cash, such as Treasury Bills and money market funds.

The Fund may use financial contracts (derivatives) only to minimize market and other risks.

The Fund seeks to outperform the MSCI Latin America 10/40 index by selecting the shares of companies that the Investment Manager believes will provide the best returns.




The charges you pay are used to pay the costs of running the Fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.
