BlueBay Emerging Market Local Currency Bond Fund

Investment objective

The fund is actively managed and targets better returns than its benchmark, the JP Morgan Government Bond Index - Emerging Markets Global Diversified (GBI-EM Global Diversified), USD unhedged.

Investment strategy

- There are no restrictions on the extent to which the fund's portfolio and performance may deviate from the ones of the benchmark.
- At least two-thirds of the fund's investments will be in fixed income bonds of any rating issued by issuers of emerging market countries (which may include securities of issuers in financial distress) denominated in the local currencies of these emerging market countries.
- Up to one-third of the fund's assets may be invested in emerging market bonds denominated in non-emerging market currencies other than local currencies as well as non-emerging market bonds. The fund may invest up to 20% of its net assets in mainland China.



Outlook

- Despite the volatile rates and geopolitical environment, markets have ended the first quarter on a positive note.
- We are now at an interesting juncture where economic data in the US remains far more resilient than the broader global economy, pointing to a risk that the Fed will be unable to meet the market's projections for interest rate cuts this year.
- Despite these risks, we believe the case for EM debt in 2024 remains strong.
- At the sovereign index level, the fiscal budget deficit is likely to narrow marginally for all EM countries as a whole, while EM credit markets remain supported by a falling default rate, and overall levels of yield still remain at attractive levels compared to history.
- Local markets remain more nuanced, however the general trend of falling inflation and high nominal yields should still provide a supportive backdrop for total returns. but we do expect some volatility as various dynamics play out.





Important risk considerations


- At times, the market for emerging market bonds may dry up, which could make it difficult to sell these bonds, or the fund may only be able to sell them at a discount. - 1. While gross of fees figures would reflect the reinvestment of all dividends and earnings, it would not reflect the deduction of investment management and performance fees.
